Kelsey Storey – some Master Gardeners reported noxious weed activity that she passed along to Brittany

Greg stated he is working on getting applications, contracts, irrigation pipelines Some of the forestry contracts will include weed control Irrigation projects in Custer county include weed management

## • Fremont Conservation District

Daniel Morse stated that 2025 elections for the district are over 79<sup>th</sup> Annual Landowner's Banquet was on April 25, 2025 First college scholarship was awarded for heavy machinery Dedication of Canon City library garden with Jesse and City of Canon City

# **Weed Director's Report:**

Brittany has been spraying and selling herbicide

Sent out contracts for Elongated Mustard and awaiting reply

Did a pesticide presentation in Custer County for Earth Day

Funding (some of it) has come in for 2025–still not definite on hiring an applicator for summer Agreement with US Forestry is in the works

BLM – still figuring out planning - bio controls for Yellow Toadflax in Teller County

### **Weed Board Member and Guest Roundtable:**

John mentioned that it should be good season

Ed is the Cooperative observer for National Weather Service

Looking to hand off daily obligation to someone in the Canon City / Lincoln Park area

Need a location at the same elevation as the Territorial Prison from 1893 – a site evaluation for suitability will be conducted

Ed is the second longest tenured observer

Donna saw a weed and told Brittany about it so that she could spray it

Tony says the Canada Thistle is growing tall

Ed says the grasshoppers are back

Tony mentioned that Beauveria Bassiana is used as a biological insecticide to treat for grasshoppers. It is a fungi that is a microbial pathogen to grasshoppers and it is also a growth stimulant for plants.
