Minutes:

The minutes from the May 19, 2025 meeting were distributed at this meeting and via email. Motion to approve minutes by Tony Telck and 2nd by Ed Norden

Chairman's Report:

Yellow Starthistle has reappeared on a ranch in Pueblo County in same place as a few years ago

Welcome Bryan Welding as a new board member appointed July of 2025 Bryan was the noxious weed inspector in El Paso County previously and relocated to Florence, Colorado in 2020 to work for Canon City.

Notification of board members with term expiration on December 31, 2025:

Paul Garrett handed in a letter requesting reappointment to the board for a term expiring 12/31/2028

Donna Landrum will be discontinuing her service on the board as of 12/31/2025

Honorary Lifetime Membership (non-voting) was discussed for Paul Telck for extra ordinary service and duty.

Tony Telck made the motion to appoint Paul Telck as a Life member to the Fremont Couty Weed Advisory Board and Ed Norder did the 2^{nd}

All board members were in favor

This leaves two open Board positions on the Weed Advisory Board: Donna Landrum's position with a term expiring 12/31/2026 Paul Telck's position with a term expiring 12/31/2028 The open positions will be posted on the Fremont County website

Agency Reports:

• Commissioner's Comments

Dwayne McFall was not present.

Tony Carochi reported on county projects:

Airport drainage project in underway.

Building Projects on East Main for Emergency Management and Search and Rescue will begin on December 3, 2025. The Fremont County Weed Management Department will have its own storage area and the Coroner's Office will have a refrigerated area as well.

County Road 67 is open again – new decking on the bridge.

Bridge number 225 will be completed in the spring.

• BLM

Aaron Rictor was not present but sent in a report through Brittany BLM will be utilizing bio controls on BLM lands

• CSU Extension/NRCS Small Acreage

Kelsey Story reported that the Master Gardner group will be presenting a Grasshopper workshop

Rick asked if anything can be done regarding grasshoppers and Kelsey stated that management – not eradication - is the line these days




Greg Langer stated just back from 43 days of furlough Application deadline for EQIP is pushed back to January 15th

Rick inquired if a weed component is included in forestry project contracts Greg stated that it is included if weeds are present

Irrigation projects occasionally include weed management plans

He circulated the snow pack report and the Drought Monitor report –





• Fremont Conservation District

Daniel Morse stated the Conservation District board voted to continue acting as the Secretary / Treasurer fiscal agent for the Upper Ark Cooperative group

Applying for portion of \$450,000 grant for 2026

The Upper Ark Cooperative is looking into hiring a 1099 position to perform plant identification, run interface with the public, and mapping

Applicator Training on February 10th at Pueblo Convention Center in coordination with Upper Ark

Thank you Brittany for presenting at the Soil Health Workshop in October

They received grant funding for workshops in 2026

The Conservation District would like to coordinate a pre-emergent workshop

Currently there is not a lobbyist for CWMA - Colorado Weed Management Association — they do have a lobbyist through the Conservation District

John Coyle had a variety of comments – he used to be a CWMA board member and is currently serving on a legislative committee

Daniel stated that as a member of the Colorado Association of Conservation Districts they can backdoor some policies to the lobbyists even though they do not have a lobbyist at CWMA

• City of Cañon City

Jessie Young discussed ordering preemergence for 2026 and getting ready to start spraying in February

Rick asked if preemergence deal with Whitetop

Esplanade / Rejuvra and Plateau being used

Rejuvra being used on lands that back up to BLM because can't use Esplanade there

Ed mentioned the signs that Brittany had installed last year – just what is needed for awareness

John Coyle talked about cheatgrass treatments with Rejuvra that he did in Chaffee County under the Make America Beautiful grant along county roadsides. He also mentioned that the manufacturer of Rejuvra has a grant writer on staff to assist with funding

Jessie talked about cheatgrass taking over the gorge – needing to floow up rock slides with herbicide treatments

John Coyle suggested combining Rejuvra Method and Vista to clean up noxious weeds cost effectively

Bryan Malek is the new Weed Manager for Chaffee County Bryan suggested applying at the state level for the BIL (Bipartisan Infrastructure Law) grant toward wildfire mitigation for cheatgrass treatment

Daniel Morse inquired about private land cost share for species not on list of grant parameters If the conservation district were to provide additional funding – would it be beneficial for her

Priorities and Procedures Manual needs to be updated to reflect changes in County Weed Management Plan – Brittany provided a hard copy to everyone at today's meeting

Ed stated that all board members should review the document and submit updates to Brittany for discussion at the January 21, 2026 meeting

New Business:

Regulatory & Program Updates (since May 2025)

1. Local Enforcement Authority

Senate Bill 24-031, effective August 7, 2024

Key change: allows county commissioners to adopt and enforce local ordinances for

noxious weed control

Penalty Range: Civil infraction of \$500 - \$1000 for violations

Relevance: Fremont County may establish or update local enforcement procedures

Source: Colorado General Assembly – SB24-031

Discussion about the county implementing a violation for Noxious Weed offense – no action

About the Upper Arkansas Cooperative Weed Management Area:

Formed in 1998, the UACWMA aims to manage noxious weeds on a watershed basis. The UACWMA is comprised of ten counties, seven neighboring Conservation Districts & includes county, state, and federal agencies as well as private landowner participation. The UACWMA applies for grant funding & shares resources across county boundaries to accomplish goals.

Biocontrol Releases

- ⇒ Puncturevine weevil (microlarinus spp.) 4 acres
- ⇒ Leafy spurge flea beetle (A. Flava, A. nigriscutis , A. lacertosa, A. czwalinae, Oberea erythrocephala) 4 acres
- ⇒ Northern tamarisk beetle (diorhabda carinulata) 4 acres
- ⇒ Field bindweed mite (aceria malherbae) 4 acres

The Palisade Insectary supplied biocontrol insects for treating leafy spurge, tamarisk, puncturevine, and field bindweed species in the 2025 season. These releases were introduced on private and county owned properties with the understanding that monitoring and cultivating practices may need to take place in future seasons.
