# **Weed Director's Report:**

Brittany discussed HB241178 – Statewide Uniformity. It died in committee.

An IGA with Custer County has been approved. Ongoing discussion with Custer County Commissioner Kevin Day.

Rick asked what weeds they would focus on and Brittany stated all Noxious Weeds on the state list.

Brittany has been receiving calls from private landowners in Custer County to treat weeds.

Brittany is setting up site visits at quarries and mines.

Brittany has been assisting with State Land Board cost share.

CDOT fiscal year ends on June 30 / July 1 – so more activity with year end deadlines approaching.

Herbicide sales at about \$4k already for the year.

Discussion on cost share – she will be putting updated information up on the website.

Rick asked if Guidelines are still available and Brittany stated that they are still on the website but they need to be updated

Kiosk Signage is still in the works.

## Weed Board Member and Guest Roundtable:

Tony Telck talked to Mannie Colon last week regarding Whitetop and he needs a follow up to get treated.

Milestone has been relabeled – no feed or livestock can be moved from area sprayed for 18 months after it has been broadcast.

Tom Grette – was a weed applicator for the County and was with BLM for 30 years prior.

Donna Landrum stated there's weeds growing out there and she is going to get out there and spray
