2. Transfer of Ownership SRU 05-007 APEX Twin Enviro

Apex Twin will be purchasing Fawn Hollow Transfer Station SRU 05-007, at 645 McDaniel Boulevard, in Canon City Colorado 81212.

Representative: Chris Brochu, General Manager of Apex Twin Enviro

Mr. Brochu explained that this is simply a transfer of ownership of the SRU 05±-007 since Apex Twin Enviro has purchased the Fawn Hollow Transfer Station.

Planning and Zoning Director Victoria said Apex Twin entered into an agreement to acquire the assets of Alpine Disposal. This purchase includes acquiring Fawn Hollow Transfer Station. Apex Twin Enviro assumes all responsibility for the performance of all obligations, conditions, and guarantees imposed upon the approved permit. Apex is aware of a few compliance issues that currently exist on the site and upon acquiring the property they plan to get it into compliance. Director Victoria said staff recommends approval for the transfer of ownership to Apex Twin Enviro.

Commissioner McFall moved to approve the Transfer of ownership for SRU 05-007 to Apex Twin Enviro. Commissioner Bell seconded the motion. Upon Vote: Commissioner McFall, aye; Commissioner Bell, aye; Commissioner Grantham, aye. The motion carried by unanimous consent.

3. SE 25-004 Golden

Subdivision Exemption is requested for 13440 County Road 45 in Coaldale. Applicant: Dawn White

Ms. White explained that she is a real estate broker and she if representing the Golden's in selling their home. She said throughout that process they realized there was a 95-acre parcel that had been cut off and the Golden's currently own and reside on the three acres. The title company addressed it by stating that they must receive a letter from the planning and zoning unit that the parcel is properly subdivided. She then reached out to the department, and they recommended she file for an exemption.

Planning and Zoning Director Victoria said that the lot is non-conforming and would need an exemption for them to sell or do anything else with the property. Director Victoria said based off the date of creation, different owners, and the land is already developed with dwelling and accessory buildings that the staff recommends approval.

Commissioner Bell moved to approve SE 25-004 Golden subdivision exemption for 13400 County Road 45 in Coaldale. Commissioner McFall seconded the motion. Upon Vote: Commissioner Bell, aye; Commissioner McFall, aye; Commissioner Grantham, aye. The motion carried by unanimous consent.

4. MS 25-004 6E Minor Subdivision

Requesting approval for a minor subdivision that will create a total of two (2) lots. Located at 540 6th Street, in Penrose. Applicant: Travis Jenkins

Mr. Jenkins said that it is a 10-acre parcel that he owns and would like to split in half. One lot would have a dwelling and utilities while the second lot would be a hay field. He wants to sell the property with the house on it. Mr. Jenkins explained that they are requesting a couple of_exemptions, one being the length requirement mandated to be less than twice the width. They split the lot this way because it's optimal for the existing irrigation of the hay field. The other exemption is the drainage plan considering they have no plans to build on the property.

Planning and Zoning Director Victoria said both lots meet minimum requirements for the zone district. Lot two barely exceeds the rule that the depth may not be twice as large as length. There is a service letter stating what the water supply for the new lot is in the Penrose Water District. The department requests that the northwest corner of the lot be designated as the area for DOT property for access and maintenance. Staff recommend approval along with approval of the two waiver requests.

Commissioner McFall moved to approve MS 25-004 6E Minor Subdivision located at 540 6th Street in Penrose which includes two waivers, the first being the waiver request for the drainage plan and until time of development and the plat note stating the northwest corner is designated DOT property concerning the septic system. Commissioner Bell seconded the motion. Upon Vote: Commissioner McFall, aye; Commissioner Bell, aye; Commissioner Grantham, aye. The motion carried by unanimous consent.

5. MS 25-001 Sinclair Minor Subdivision

Requesting approval for a minor subdivision that will create a total of two (2) lots. Located at 350 Sangre De Cristo Drive in Coaldale.

Consultant: Attorney Gwendolyn Allen

Ms. Allen said she is the one representing the owners of the 55-acre parcel and they are requesting to split the parcel into two. Lot two consisting of 20 acres that will have the dwelling on, and they plan to sell the other 35 acres to people that intend to use it for agricultural purposes. She stated that the owners are requesting a waiver of the public road requirements considering the easement road they are referring to services other properties that aren't owned by the same people.

Planning and Zoning Director Victoria said the planning and zoning department recommended denial due to Fremont County Subdivision regulation concerning fronting on a public road, access to a public dedicated street, and the sidelines of lots at right angles to a street. The planning and zoning department recommends these contingencies if the board decides to approve; they provide a letter from division of water resources dates March 5th, 2025, to reclassify the well conditions. A plat note stating that drainage must be done at time of development and topsoil information required at time of development.

Tom Pervis explained that the purpose of acquiring this land it to use it to farm and livestock. He said significant work has been put into fixing the irrigation and drainage. He has discussed this proposal with surrounding neighbors, and no one has any concerns.

Commissioner Bell expressed concern regarding the fact that they may be allowing this subdivision but with the way this area is zoned it should not be reduced any further and she is worried this move would encourage others. Commissioner Bell suggested that they table this item and wait to receive letters from the owners of lot 19 and 20 stating they understand the intent with this subdivision and that they are comfortable with it, especially concerning the use of the road.

Ms. Allen said the preference of the owner would be approval today contingent on providing those letters from the neighbors along with the other contingencies.

County Attorney Bellas suggested a brief recess for the applicant to discuss the options.

Commissioner Grantham called a brief recess.

Commissioner Grantham called the meeting back to order at 10:16am.

Ms. Allen confirmed that the owners would prefer to table the application until letters from owners' Lots 19 & 20 provide the department with a letter stating they are comfortable with the changes.

Commissioner McFall moved to table agenda item number seven to November 10th at 9:00am BOCC meeting. Commissioner Grantham seconded the motion. Upon Vote: Commissioner McFall, aye; Commissioner Grantham, aye; Commissioner Bell, aye. The motion carried by unanimous consent.
