2. **Resolution No. 43**, Series of 2024, Adopting the Emergency Operations Plan for the County of Fremont, State of Colorado Representative: Mykel Kroll, Fremont County Emergency Manager

FCE Manager Kroll explained that the Emergency Operations Plan must be renewed or updated every five years which is required by FEMA and state guidance. He explained that this plan is created from collaboration with other departments around the country and state to decipher the best practices of responding to emergencies and relying on elected officials to organize other departments to be able to work together on emergencies.

Commissioner McFall said that they made a change to the resolution that states in the event of the board of the Fremont County Commissioners cannot be timely convened and the director of the office of Emergency Management with the concurrence of the County Administrator and the singular Commissioner are herby authorized to spend up to \$250,000.

3. **Resolution No. 44**, Series of 2024, Establishing Fees for Submission of Applications Pursuant to Fremont County Guidelines and Regulations for Matters of State Interest (1041 Regulations)

Representative: Dan Victoria, Fremont County Planning & Zoning Director

Planning & Zoning Director Victoria began the presentation by explaining that they came up with this fee schedule by researching surroundings counties schedules and with the consideration that these are base fees and that there will most likely be other fees to pay during the process. For permit types there is the FONSI (Finding of No Significant Impact) for \$5,000 and the 1041 Permit is \$10,000 both permits had additional costs of \$200 an hour per staff member for the review after the initial permit fee has been exhausted. In addition, consultant fees will be passed along to the applicant. This cost is for the applicant to cover their own costs and not use taxpayer money.

Commissioner McFall said the board already approved these regulations a couple weeks ago, but they do not go into effect until January 1st, 2025, so the Planning and Zoning Department had time to create this fee schedule.

RESOLUTION HONORING COUNTY ATTORNEY BRENDA JACKSON ON HER RETIREMENT

WHEREAS, Brenda Jackson, Esquire will retire on December 31, 2024, after about thirty-three years of distinguished service as Fremont County Attorney; and

WHEREAS, Brenda began her service to the County on January 14, 1992, serving as County Attorney while still maintaining a local full-time private law practice; and

WHEREAS, as a result of demonstrated legal ability, strong work ethic, and the County's increasing need for professional legal services, Brenda transitioned to become the full-time County Attorney on January 1, 2001; and

WHEREAS, Brenda has served with distinction as County Attorney for eleven Boards of County Commissioners and with sixteen individual County Commissioners; and

WHEREAS, there are scarcely enough superlatives to describe Brenda's contribution to the County or the esteem in which thirty-three years' worth of Commissioners have held her, having described her as "reliable," "exceptional," "extremely professional," "team player," "efficient," "outstanding" and, perhaps most importantly, "trusted;" and

WHEREAS, during her tenure, Brenda has deftly guided the County through good times and challenges, including acquisition and construction projects, an ever-changing legal and regulatory landscape, land use planning and economic development, and disasters both local and global; and

WHEREAS, Brenda has forever left her mark on the facilities and landscape of Fremont County, including the construction of a new Sheriff's Office and Jail, a new Courthouse, and a new home for the Department of Human Services; renovation of the Fremont County Administration and Garden Park buildings; acquisition and construction of Pathfinder Park, the Fremont County Emergency Response Center, Ecology Park, the Col. Leo Sidney Boston War Memorial Park; and expansion of the Fremont County Airport; and

WHEREAS, Brenda has given the Board of County Commissioners invaluable and trusted legal advice regarding land use planning by keeping the Fremont County Zoning Resolution and Subdivision Regulations relevant and up to date and by shepherding the complex process of development and adoption of 1041 regulations regarding matters of statewide interest; and

WHEREAS, Brenda has protected the interests of the County through such challenges as the legalization of marijuana, the Royal Gorge Fire, a devastating ransomware cyberattack, and a global pandemic; and

WHEREAS, Brenda has been recognized by her community for her outstanding leadership, her lifetime of contributions to the Fremont County community, and her professional achievement, being named Fremont's Exceptional Professional Woman in 2017; and

WHEREAS, Brenda has also been recognized by her peers as an AV Preeminent lawyer, the highest possible peer review rating in legal ability and ethical standards; and

WHEREAS, Brenda served Fremont County beyond its borders as an Executive Board Member of the Colorado County Attorney's Association for nine years; and

WHEREAS, Brenda's stalwart presence and sound advice have enabled decades of Boards of County Commissioners, including this one, to confidently make decisions in the best interest of the County, knowing that the County's legal interests are being protected.
