Mrs. Elliot said this event is to celebrate National Hamburger Day and to support local businesses with business after hours hosted by Florence Chamber of Commerce.

Clerk Grantham began the staff report by saying the 45-day requirement was met, and the proof of posting was sent before the 10-day requirement. The Sheriff, Public Health, and attorney all recommended approval.

Commissioner McFall asked how the organization will ensure no one under the age of 21 will consume alcohol and if the staff is trained.

Mrs. Elliot answered that the customers will only be allowed two drink tickets, identification will be checked at the bar and all servers are TIPs certified.

Commissioner McFall moved to approve the issuance of a fermented malt beverage special events permit for Florence Chamber of Commerce for an event at Venue at Oak Creek located at 800 N Frazier Ave in Florence for the following dates: May 28th from 5:00pm to 7:00pm and September 17th from 12:00pm to 7:00pm. 2. TUP 25-002 950 Junktion

The owner/applicant is requesting a Temporary Use Permit to allow a vintage / flea market. Applicant: Tracy Vinton

Mrs. Vinton said that the TUP request is for June 21st, June 22nd, July 19th and July 20th from 10:00am to 4:00pm. Most of the vendors will set up inside and a few outside with two being food vendors. The merchandise consists of antiques ranging from vintage art and apparel.

Mrs. Adamic said the event will take place on private property owned by the applicant. There will be 15 vendors in total with two being food trucks. The location is 43880 West US HWY 50 which is just outside the city limits of Canon City. This is the third time 950 Junktion has applied for a TUP with no issues. The applicant will supply bottled water, and Twin Enviro will provide the chemical toilets. The Sheriff's Office and Colorado State Patrol approved their fire protection plan. The Planning and Zoning Department recommended approval with the following recommendations and conditions, that they obtain a permit for the chemical toilets for the weekend in November considering the current permit is only good until then and if the food trucks are not licensed through Fremont County that they visit the Public Health Department.

Commissioner McFall moved to approve TUP 25-002 95 Junktion located at 43880 West US HWY 50 this will be for the dates of June 21st and 22nd, July 19th and 20th, August 9th and 10th, September 6th and 7th, and November 8th and 9th with the approval of the surety bond waiver and that the applicant renews the chemical toilet permit for November as well as making sure the food trucks are licensed. Commissioner McFall seconded the motion. Upon Vote: Commissioner McFall, aye; Commissioner Grantham, aye. The motion carried by unanimous consent.
