**Clerk Grantham** gave the County Clerk's Monthly Report, which can be found in its entirety at <u>www.fremontcountyco.gov</u>.

**Commissioner Bell** wanted to publicly recognize someone from the Fremont County staff that will be celebrated at a special event taking place at the Denver Zoo. A team of agencies are coming together to recognize collaborative efforts that help families stay together. The celebration will include distinct recognition of Colorado's reunification hero honorees, remarks from local leaders, family activities, and a special lunch. Fremont County's own Jaquelyn Wilner,, child welfare caseworker 4, is one of the reunification heroes who will be celebrated.

**Commissioner McFall** said that they all attended the Colorado Counties Incorporated Summer Conference last week. He found it interesting to gather all the differences, advantages, and disadvantages from county to county in Colorado. Various subjects were discussed such as water rights, nuclear power, and agriculture.

**Commissioner Grantham** said that he would like to point out the wonderful staff from the Veterans Office that Fremont County has. Marty Peek, who is the director, put together a report for the year which accumulated to 4,876 total contacts which entails phone calls, emails, and in office visits. He also announced that since the radio station has been shut down the commissioners have been brainstorming about a different way for information to be spread to the public. The solution they came up with is to host a podcast that features the commissioners and occasional other guests called One Fremont which is accessible on Fremont County's YouTube channel and Facebook page.

**Maxwell Hansen** introduced himself as the new constituent service representative for Congresswoman Brittney Patterson. He brought up the fact that our area is prone to wildfires, and he extends any service

that he may be able to provide in the event it happens again such as helping facilitate any discussions with federal agencies and partners.

**Karyn McClure-Kent** asked the commissioners to direct her on where she could obtain a copy of her birth certificate since she was born in England but was brought to the United States after being adopted by her parents that were in the military.

**Commissioner Grantham** suggested she meet with Mr. Hansen since he is the congressional representative.

Ms. McClure-Kent asked about the lack of availability of internet in the area.

**Commissioner Bell** responded that they have been fighting for years to obtain it in Fremont County. She said they obtained some funds from the American Rescue Plan Act that they planned to pledge funds to expand internet service but there are no businesses interested in partnering with them with the budget that they have available.

**Mrs. Hilterbran** said that she and her husband are requesting the extension because they need more time to finalize the request of a SRU and the acquisition of the purchase for the property.

**Planning and Zoning Director Victoria** began the staff report by introducing the applicant and application. The request is to extend the TUP until December 31<sup>st</sup> of 2025. The department did not have any complaints, and the applicant appears to be in compliance with the department's policies.

Commissioner McFall asked if it is realistic that everything will be finished by the end of this year.

**Mrs. Hilterbran** answered that the appraisal could take months as well as the title work on the property, but she has been assured that everything should be done within this new timeframe.

**Ms. Perdue** said this event is the annual Marine Corps Ball, they limited the tickets to 200 people, and they have sold approximately 120. Bar Hoppers will be providing and managing all the alcohol sales at the event with her TIP's certified servers. The security for the event will be newer and more seasoned veterans.

**Ms. MacKinnon** said the event will be called Wine Whiskey Pull, they will charge \$15 a person or \$25 a couple. They will also be auctioning off several bottles of wine and whiskey, she said they will make it clear to all buyers that you are not allowed to open any of the bottles on the premises. What will be served is a glass of wine or a bottle of beer and then they will charge around five dollars for any additional drinks.

**Clerk to the BOCC Ryan** said that the application was fully filled out and made the 45-day requirement. The public health and sheriff report were sent out on April 15<sup>th,</sup> and both came back recommending approval. The proof of posting was provided well ahead of time, so the Clerk's office recommended approval.

4. Secure Transportation Service License and Permit for Netsanet Yohhanes dba Rocky Trip LLC

**County Attorney Bellas** explained that the board has had to issue a number of these licenses and permits the past several months. These are for behavioral health transportation services, the level of care provided is a level below emergency medical services. There are Class A and Class B, Class A transportation services allow the transporter to use an element of physical restraint if needed. Class B does not allow any kind of physical restraint. Concerning the permitting of a vehicle there are also two types, Type One has a glass barrier between the driver and passenger. Type Two does not have any type of barrier.

**Commissioner McFall** moved to approve secure transportation license for Netsanet Yohhanes doing business as Rocky Trip LLC for Class B secure transport license with a Type Two permit for 2021 Toyota Rav 4 van number ending in 6391 starting on June 10<sup>th</sup>, 2025, and ending on June 10<sup>th</sup>, 2028. The vehicle permit is valid for one year. Commissioner Bell seconded the motion. Upon Vote: Commissioner McFall, aye; Commissioner Bell aye; Commissioner Grantham, aye. The motion carried by unanimous consent.
