

**RESOLUTION NO. \_\_\_\_\_, SERIES OF 2025**

**A RESOLUTION LEVYING GENERAL PROPERTY TAXES FOR THE YEAR  
OF 2025, TO HELP DEFRAY THE COSTS OF GOVERNMENT FOR THE  
COUNTY OF FREMONT, COLORADO, FOR THE 2026 BUDGET YEAR.**

**WHEREAS**, the Board of County Commissioners of the County of Fremont has adopted the annual budget in accordance with the Local Government Budget Law, on December 16, 2025, and

**WHEREAS**, the amount of revenue necessary from property taxes to balance the budget for each fund is as follows:

<b>GENERAL FUND</b>	<b>\$ 5,441,860</b>
<b>ROAD AND BRIDGE FUND</b>	<b>\$ 613,228</b>
<b>HUMAN SERVICES FUND</b>	<b>\$ 1,948,623</b>

**AND WHEREAS**, the 2025 valuation for assessment for the County of Fremont (for 2026 Budget Year) is certified by the County Assessor to be **\$ 721,445,106**.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of County Commissioners of the County of Fremont, Colorado:

1. That for the purpose of meeting all expenditures of the various funds, as listed above, during the 2026 budget year, there is hereby levied a General Property Tax Rate of 11.443 mills upon each dollar of the total valuation for assessment of all taxable property within the County for the year 2025 (payable in 2026), distributed as follows:
