



<p>Fremont County is requesting a 12-month extension to our grant. We would like to request that the grant be extended to 12/31/2025. Fremont County applied for matching funds through a DOLA Energy and Mineral grant and were awarded but unable to enter contract until our 2022 audit was completed. The audit was delayed due to a cyber event that took place in 2023 and staff turnover in our Finance Office. We were advised by DOLA to wait to begin work until we were under contract. The audit has been completed and DOLA is working on executing the contract for the grant award. The contract is anticipated to be executed in the next few weeks and Fremont County will begin work at that time. The new grant award end date will be December 31, 2025.</p>
