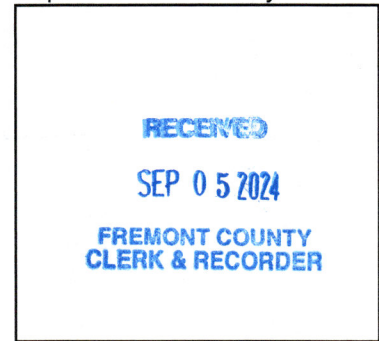

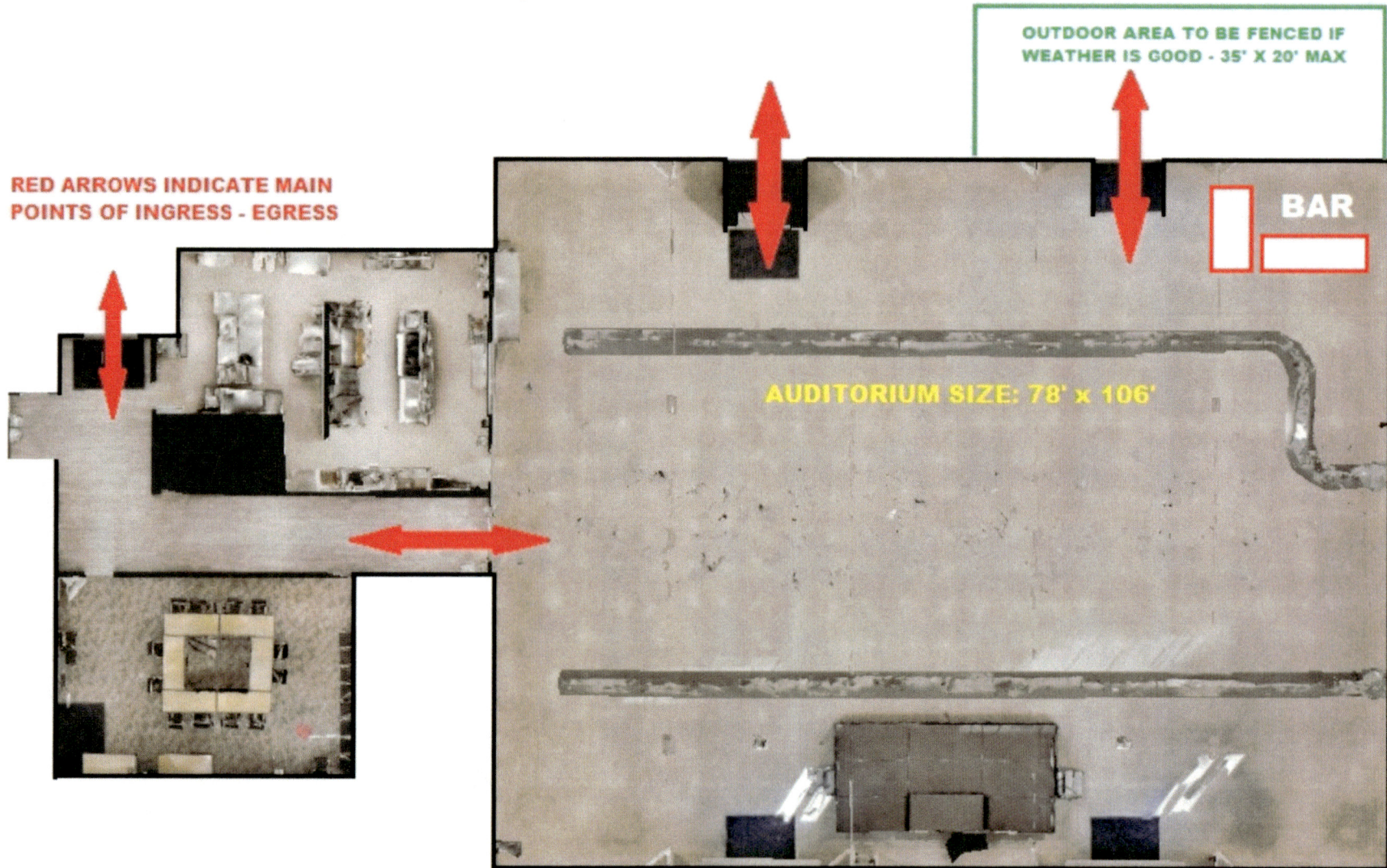

As such, they have our permission to go ahead and apply for a special event liquor license.

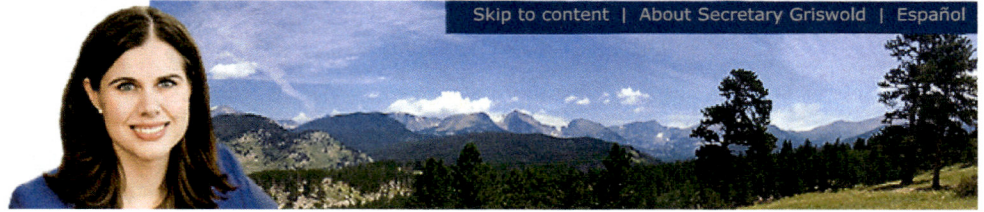
