Per our conversation this morning, the following is a timeline of correspondence regarding the Marchand Ranch Wedding & Event Venue.

- March 26, 2024 CDOT received a planning referral request from Fremont County for the Temporary Use Permit (TUP-24-004)
 - April 8, 2024 CDOT's response was sent to Fremont County and Tiffany Foster with Marchand Ranch
- April 11, 2024 CDOT received the Roadway Impact Analysis Form from Fremont County for the Temporary Use Permit (TUP-24-004) for review and comment.
 - April 15, 2024 CDOT's response was sent to Fremont County and Tiffany Foster with Marchand Ranch
- April 16, 2024 I received an email from Annette Reed-Pugh with Fremont County asking questions about filling out the CDOT Access Permit application. I responded to the email with suggestions for the application as well as the documents that would be required when the application was submitted.
