#### **Rules:**

- All entrants must be 17 years or younger and a resident of Fremont County on submission date
- All artwork submitted must be your original work; no stock or "borrowed" images may be used
- Entries must include the words "Future Voter"
- Artwork must be nonpartisan

- Be sure to save a copy of your original work; artwork will be submitted in the form of a scanned file of the image, but we will need the winner's original artwork to create the stickers
- The attached release must be signed and submitted with your artwork
- Hand drawn entries must use the attached template
- Return your template or digital file to the Election Division at 615 Macon Ave. LL6, Canon City, CO 81212 or elections@fremontco.com

### Digital submission specifications:

- Must be 300 dpi resolution or higher
- Must use CMYK color
- Save your file so you can later export with crop and bleed marks and color information
- Must have at least a 1/8" bleed

The top 5 finalists will be determined by the Clerk and Recorder's Office. The public will vote on the winner of the 5 selected finalists. Thank you for your participation!
