b. County Manager Report, Tony Carochi, County Administrator

County Administrator Carochi gave the County Administrator Report, which can be found in its entirety at www.fremontco.com.

Commissioner Bell announced that Mr. Carochi's title will change from County Manager to County Administrator. After consideration, administrator sounded more appropriate for the job that he performs.

Commissioner McFall said that next week a legislative session will take place in Denver. He also stated that, thankfully, last year's land use bill 213 failed, but this year they are going to attempt to sneak it through in small separate bills to gain control of land use instead of it being locally controlled.

Commissioner Grantham also mentioned bill 213 from last year's legislation and said that it would have caused drastic changes to the structure of how land use is administered, giving power to the state. He said the Board of Fremont County Commissioners, CCI *Colorado Counties Incorporated*, and CML *Colorado Municipal League* are obviously against this, stating the municipalities could be impacted the most considering the bill is aiming to change land use to be denser. Grantham said that CCI and CML will lock arms in the fight against these bills, because this year they are going to attempt to get multiple small bills passed that, collectively will be the 213 bill from last year. Legislation is hoping to get at least some of it passed with the strategy of divide and conquer.

Clerk Grantham wanted to remind everyone that the election is in March. He also wanted it to be known that President Trump will be on the ballot, it has been certified. The Supreme Court will be having a hearing in February to decide if Trump is eligible to be a presidential candidate, so things may change. This is the time to update your voter registration if it is needed. If you are registered as non-affiliated, you will receive a Democratic and Republican ballot, but only turn in one because if both are turned in, neither will count. Every person is only allowed one vote.

2. Citizens who wish to address the Commissioners on a matter not scheduled on the agenda

John Zimmerman said that he is concerned about the 224 unit or 50-megawatt battery storage system they are wanting to build up at 8 Mile, which is located next to his house. He said the location is in a fire shed and Fremont County really needs to investigate this because there are no regulations for this, and there is a huge risk of fire. There is access to WAPA Western Area Power Administration line giving them incentive to build this battery storage. The WAPA line services all the hydroelectric powers in the Western Unites States, that's why it is so appealing for them. Mr. Zimmerman asked the fire department what the plan is if this gets built next to his house and then inevitably catches on fire. He believes that it isn't just a danger to him, but the whole city since it is only four miles out of town. Based on how fast the Royal Gorge fire spread, seven miles in four hours, it would reach Canon City in a matter of a couple hours. He said there were 34 events last year of these storage places spontaneously catching on fire, and that one is burning in Alaska right now.

Liane "Buffie" McFadyen also spoke about the battery storage system, saying that the Planning and Zoning Department has been very receptive and helpful explaining the process, and she believes it should stay within local government, considering that most counties have unique areas. Considering 8 Mile is close to a substation, and if a moratorium was developed it would give the very knowledgeable people in Planning and Zoning Department the time to develop criteria for citing and reviewing a master plan to make sure it coincides with the Fremont County master plan. It would also allow time for them to consider the health, safety, and welfare of Fremont County citizens. Not to mention the physical, economic, and social impact on Fremont County. Ms. McFadyen worries about the amount of toxins that would be released if a fire were to occur. These lithium-ion batteries leak toxins and at the least a reporting mechanism needs to be created and regulated by the Air Quality Control Commission.

Ashlee Sack said she works for Fremont Adventure Recreation and believes Fremont County is one of the luckiest counties in the state because of the amount of public land it has, such as federal land, city parks, county parks, and centennial ranches. She believes Governor Polis created executive order B2020-008 to give communities the ability and responsibility to start protecting the future of the wildlife and land of Fremont County. The idea is to come together from different communities and counties and put together a comprehensive list of priorities, whether that be historic ranches, wildlife, or farms. Ms. Sack is inviting the Commissioners to their very first meeting, which be held on January 25th, 2024, at 4:00 pm located at The Hive.

Kyle Horne added to Ms. Sacks's comments that the true importance lies in the funding, and the intention was to apply for the National Park Service Grant, but they are not eligible. In other grants, the problem being brought up a lot, is that the district, the city, or the county needs to apply for that. Mr. Horne is asking for there to be a collaboration because that is the key to getting this funding.

Clerk Grantham gave the staff report, saying the Clerk's office sees no issues with the application, and all necessary documentation was submitted on time. Budget and Finance Officer Sutton said the finance department sends out 37 different requests to municipalities, special districts, and other entities for mill levy certification. It is typically due December 15th; however it was extended to January 10th, 2024, due to the special session. The mill levy requires a lot of collaboration, verifying the numbers, and reaching out to stray entities. The final step is to certify the mill levies form the different entities. The certificate is typically due back to the state by December 22nd; however, it was also extended due to the special session to January 17th, 2024. He said they have received 24 of the 37 certificates back. The other 13 have been contacted and those are believed to be coming in tomorrow, January 10th, at 5pm, and to the state by January 17th. The next step is to have it certified by Tony Carochi, County Administrator, then it will be given to the commissioners, and finally sent to the state. No resolution is required.

County Attorney Bellas said that from time to time the county will end up in possession of some personal property that has value, or some utility, at which the county cannot find the owner. At that point, the Board of Commissioners has the authority to determine the disposition of that property. It should be made clear that the commissioners are not interested in taking people's property, this only applies when the owner of the property cannot be found, or if the property cannot be returned to its rightful owner because it is an illegal property to possess. This resolution will basically allow an elected official and county department head who comes into possession of that property, to determine whether they believe it is in the best interest of the county to retain it for use if it cannot be returned to the owner. It does not apply, for example, to a motor vehicle. Mr. Bellas said there is an example of such a property currently. It is being held by the Sheriff's Office. It was originally owned by a business entity which has ceased all business operations with no successor, and that property could be useful to the Sheriff's Office, or to other county departments. This resolution will allow the Sheriff to make the determination if the property is useful and to notify the County Administrator of a desire to retain it.
