Enclosed please find a funding request for Fremont County. The request is from the Colorado Mission of Mercy (COMOM). A financial contribution of \$10,000 would assist COMOM to provide County residents with free dental services. In particular, the funding would help to purchase dental supplies not acquired through in-kind donations.

COMOM is a portable, dental clinic that is held annually in a Colorado community. On September 24 and 5, 2021, Canon City's Harrison School will be transformed into a large-scale dental clinic. Nearly 200 dentists from across the state, along with hundreds of dental hygienists, dental assistants, and an array of other volunteers, will provide 1,000 patients with \$1,000,000 in quality oral healthcare services.

COMOM is working in tandem with social service organizations in Fremont County to ensure individuals who are in dental need are aware of the program. Once at the clinic, dentists and dental hygienists will provide patients with cleanings, fillings, root canals, and extractions. Porcelain crowns, partial dentures, and full dentures will also be prepared.

In addition to the funding request, enclosed please find the clinic budget, the IRS nonprofit determination letter, and the final report from the 2015 COMOM that was held in Canon City.

Mission

The Colorado Mission of Mercy (COMOM) is a portable, large-scale dental clinic that is held annually in a Colorado community. The mission of COMOM is to provide quality dental services, at no cost, to individuals of all ages who cannot afford and access dental care; eliminating dental pain, promoting oral health, creating smiles, and providing oral health education.

History

At its inception in 2007, COMOM was a program of the Colorado Dental Association's Charitable and Educational Fund. In 2010, the IRS identified COMOM as a separate, nonprofit, tax-exempt 501(c)3 organization.

Since 2007, COMOM has served 17,000 patients and provided nearly \$15,000,000 in donated dental care.

PROGRAM DESCRIPTION – 2021 CANON CITY COMOM

The 14th annual COMOM dental clinic will be held in Canon City on Friday, September 24, and Saturday, September 25, 2021. Patient outreach will extend throughout Fremont County.

An outpouring of nearly 200 volunteer dentists from across the state – along with hundreds of dental hygienists, assistants, lab technicians, and a myriad of lay volunteers and other health professionals – will work in tandem with community groups and agencies to better the oral health of individuals who are need.

The Harrison School will be transformed into a large-scale dental clinic. Patients will undergo a health and dental evaluation, and then be provided with cleanings, fillings, root canals and extractions. COMOM dentists and dental lab techs will also prepare ceramic crowns, dentures, and flippers.

FUNDING REQUEST - \$10,000

COMOM is requesting a financial contribution of \$10,000 from Fremont County. The funding would assist COMOM to provide County residents with free dental services, and in particular, would help to purchase dental supplies not acquired through in-kind donations (note page 5).

As a nonprofit organization, COMOM is dependent on in-kind donations and financial contributions and is a steward of financial responsibility with its funds.

- During its annual clinic, patients are provided with more than \$1,000,000 in donated services.
- Clinic expenses total \$250,000.
- Based on these expenses, COMOM's volunteer dentists and hygienists provide oral healthcare services at a ratio of 4:1.




FINANCIAL SELF-SUFFICIENCY

Oral health is inseparable from general health. Individuals with gum disease and poor oral health are at higher risk for heart disease, strokes and clots in the extremities. Oral disease affects the ability to eat and also how a person looks and communicates.

Financial Insecurity. Many individuals living in Fremont County are in financial jeopardy, and would be in need of no-cost dental services. Since 2014, students in prekindergarten through twelfth grade in the County have been consistently eligible for free or reduced lunches at higher rates than those across Colorado.

Percentage of Students Prekindergarten through 12th Grade eligible for Free or Reduced Lunches*

Public school students qualify for free lunches if their family's income is less than 130 percent of the federal poverty level (FPL). Students qualify for reduced price lunches if their family's income is less than 185 percent of FPL. (CO Dept. of Education, 2019.)

Dental-related problems are widespread among individuals experiencing financial insecurity, and these oral health issues prevent individuals from seeking work opportunities and becoming more financially secure.

A person who has limited income often fears being judged by the way s/he looks, and a smile impacts how a person feels. COMOM strives to improve patients' dental appearance to help enhance potential employment prospects and to improve their self-esteem. For example, a volunteer dentist explained:

A patient had missing anterior teeth for several years. I inserted his new flipper. He grinned and said "I came in looking like a jack-o-lantern, and I'm leaving with a smile! Now I can look for a better job!"





Further, individuals who have limited income may be apprehensive of even seeing a dentist. The uneasiness can stem from pain, but patients in a dental office are in a situation in which they can hardly talk or respond. The fear can derive from the lack of control a patient may feel in the dentist's chair.



COMOM dentists provide patients with a positive experience serving as a conduit for future dental care. As two patients described: "I was always afraid of dentists, and now I am no longer afraid. I had no pain and now my whole body feels better" – and – "The dentist introduced himself and made me feel very comfortable before the procedure began. He talked softly and kept me informed on what was going to be done."

Self-Sufficiency. A COMOM focus is to provide patients, including those who have limited incomes or are homeless, with tools that encourage self-sufficiency.

In order to promote sustained oral health, and to mitigate future pain, patients are given one-onone instruction on how to care for their teeth and the importance of balanced nutrition and preventive dental care. Patients are then given a toothbrush, toothpaste, and floss to take home.

Since regular dental visits allow a dentist to find early signs of decay/disease and to treat problems at a more manageable stage, each patient receives a list of low-cost dental care options for further treatment. This document is reviewed with the patient during the exit interview process.

EXPECTED RESULTS

The central goal of the COMOM initiative is to provide quality oral healthcare services to children, adults, and elderly who are in dental need and unable to afford dental care.

In 2015, COMOM held its clinic in Canon City. As shown in the table on page 4, dentists and dental hygienists saw 1,196 patients, performed nearly 7,000 dental procedures, providing \$1,151,113 in donated care.

Addressing COVID-related concerns, the objectives for the 2021 return to Canon City, are to see 1,000 patients, and to again provide more than a \$1,000,000 in dental services.

Given the importance of oral health instruction for long-term impact, COMOM has as another objective to provide more than 90 percent of the patients with instruction.



PROGRAM-SPECIFIC BUDGET 2021 Canon City COMOM

Funding from Fremont County would assist COMOM to purchase DENTAL SUPPLIES not acquired through in-kind donations. The dental supplies to be purchased would include composite, bonding agents/etchants, and polishing materials, among other restorative, surgical, prosthodontic, and endodontic items. In addition, funds would assist in purchasing needed personal protective equipment (PPE).


