RESOLUTION ORDERING AND ADOPTING RULES, OFFICIAL HOURS AND CONDITIONS GOVERNING THE USE OF PATHFINDER REGIONAL PARK, B.F. ROCKAFELLOW ECOLOGY PARK, WESTERN FREMONT COUNTY PARK, AND COL. LEO SIDNEY BOSTON WAR MEMORIAL PARK, GOVERNED AND MANAGED BY FREMONT COUNTY, COLORADO

WHEREAS, the Fremont County Board of County Commissioners is empowered pursuant to §30-11-101, and §30-11-107, C.R.S. to purchase and hold real and personal property for the use of the county, and to make such orders respecting county property as may be deemed conducive to the interests of the inhabitants; and

WHEREAS, the Board of County Commissioners for Fremont County is the governing body of Fremont County and is responsible for the management and operation of county real and personal property, including the public parks under the county's jurisdiction; and

WHEREAS, the Board of Commissioners has determined that the formal adoption of rules and conditions for the four public parks under the authority of the County would serve the health, safety and welfare of the citizens of Fremont County and provide consistency and clarity regarding the use of the parks by the general public.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Fremont County hereby declares that the rules, conditions and directives ordered pursuant to this Resolution shall control the use of the parks by the general public and shall be enforceable within the boundaries of the parks.

BE IT FURTHER RESOLVED, that Fremont County may grant exceptions to one or more rules, conditions and directives on a case-by-case basis to accommodate county-approved, organized events. Written approval must be obtained in advance of the event.
