Commissioner Bell, in regards to an item later on the agenda, asked Ms. Elliott how many more uncollectable taxes there are in Fremont County and if that is something that needs to be looked at on a wider basis.

County Treasurer Kathy Elliott said that her office has been trying to clean some of that up and would get a list of the remaining items and possibly get it on the agenda for the next meeting.

c. County Manager Report, Sunny Bryant, County Manager

County Manager Bryant said that the CARES Act Funds have been closed out. She said that the county was able to give out over \$1.8 million in grants to small businesses, and recovered over \$400,000.00 in expenses for various departments in the county. Ms. Bryant also stated that the construction of the second-floor courtroom in the Judicial Center is scheduled to start this month and should be completed by the end of March 2021.

Commissioner Bell reminded citizens that the commissioners along with CCI (Colorado Counties Incorporated) and the Colorado Municipal League worked diligently to secure \$4.2 million in CARES Act Funds for Fremont County. She said that of those funds the county retained and dispersed, as County Manager Bryant stated, \$2.2 million. Ms. Bell took the opportunity to thank County Manager Bryant and her entire staff for all the time and work it took to review the grant applications and release the funds to the qualified businesses and non-profits.

County Manager Bryant added that even though one of the eligible expenses for the CARES Act Funds is salaries to over-see the managing of the funds, the finance department did not retain any of the funds for this purpose.

Commissioner Bell noted that the newly elected district 1 Commissioner, Kevin Grantham, was sworn in to office earlier in the day as well as the re-elected district 3 Commissioner, Dwayne McFall.

Commissioner Grantham thanked Commissioner Bell and congratulated Commissioner McFall for his re-election. Mr. Grantham also thanked the citizens of Fremont County for placing their trust in him. He said that former Commissioner Payne left big shoes to fill.

Commissioner McFall congratulated Commissioner Grantham and also thanked Fremont County citizens for re-electing him. He said that he is excited to complete some projects that he has been working on for the past four years including the community building at Pathfinder Park. Mr. McFall also thanked County Manager Bryant and her department for the work they put in on the CARES Act Grants.

County Attorney Jackson noted that other than minor typographical errors there have been no changes since the first reading of the ordinance on December 1, 2020. She said that the changes in this ordinance prohibit combined care giver grows in Fremont County.

Commissioner Grantham moved to approve Ordinance 1-2020—Second Reading and Adoption of Amendments to the Residential Cultivation of Marijuana, Ordinance 1-2017 Commissioner Bell seconded the motion. Upon Vote: Commissioner Grantham, aye; Commissioner Bell, aye; Commissioner McFall, aye. The motion carried by unanimous consent.

15. Reappoint Daniel Petersen to the John C. Fremont Library District Board of Trustees for a five-year term ending December 31, 2025

Commissioner Bell said that the board had received a recommendation from the John C. Fremont Library District Board of Trustees to reappoint Daniel Petersen to the John C. Fremont Library District Board of Trustees for a five-year term ending December 31, 2025.

County Clerk Grantham explained that the kiosk pilot program was started by Arapahoe County, with participation from the Fremont County motor vehicle department, is now being transferred to the State of Colorado. Mr. Grantham said that the contract would need to be changed from Arapahoe County to the State of Colorado. He added that the kiosk will eventually be able to offer many more services to citizens. Mr. Grantham also said that this program is at no cost to Fremont County.

ORDINANCE NO. 1 SERIES OF 2020

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF ORDINANCE NO. 1, SERIES OF 2017 REGULATING THE CULTIVATION OF MARIJUANA ON RESIDENTIAL PROPERTIES; IN RESIDENTIAL STRUCTURES; IN ACCESSORY STRUCTURES ON RESIDENTIAL PROPERTY; ON VACANT OR UNOCCUPIED LAND; AND ON NON-RESIDENTIAL PROPERTY

WHEREAS, Fremont County, Colorado has the authority pursuant to C.R.S. §30-11-101(2) to adopt and enforce ordinances and resolutions regarding health, safety and welfare issues; and

WHEREAS, the Colorado Constitution Article XVIII, Section 14 and the Colorado Medical Marijuana Code, C.R.S. §§25-1.5-101, et seq., recognize that local governments retain authority to regulate the cultivation of medical marijuana; and

WHEREAS, the Colorado Constitution, Article XVIII, Section 16 and the Colorado Marijuana Code, C.R.S. §§44-10-106-106.5, recognize that local governments may regulate the personal use of marijuana to serve the purpose and intent of the constitutional and statutory provisions regarding such use; and

WHEREAS, no person is allowed to possess, cultivate, grow, use or distribute marijuana in any manner or for any purpose other than that allowed by the Colorado Constitution and Colorado State Statutes, and local laws and regulations; and

WHEREAS, the Board of County Commissioners for the County of Fremont has determined that the adoption of regulations governing the residential cultivation of medical and personal-use marijuana is necessary and desirable for the health, safety and welfare of the citizens of Fremont County; and

WHEREAS, Fremont County currently has in effect Ordinance 1-2017, approved on December 12, 2017 to govern and regulate residential cultivation of medical and personal use marijuana in the unincorporated areas of Fremont County; and

WHEREAS, the Colorado Legislature has enacted certain changes to the Colorado medical marijuana program which require the amendment of Fremont County Ordinance 1-2017, regulating cultivation of marijuana on residential properties; and

WHEREAS, pursuant to the provisions of this Ordinance, 1-2020, certain provisions of Ordinance 1-2017 shall be amended, as provided herein.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF FREMONT COUNTY, COLORADO:

1. Section 6 of Ordinance 1-2017 is hereby amended as follows:

Section 6. General Provisions for Indoor or Outdoor Cultivation of Medical and Personal use Marijuana on Residential Property in Unincorporated Fremont County.

E. Medical marijuana caregivers may cultivate on residential property for up to five (5) persons who do not reside at the property, if the property is the caregiver's primary residence and the caregiver has been designated as caregiver by the medical marijuana patient. In no event, shall a caregiver be allowed to cultivate for more than five (5) patients without obtaining a valid medical marijuana business license from the County. Two or more primary caregivers shall not join together for the purpose of cultivating medical marijuana.

H. Plant Count Limit.

- (1) No more than 12 marijuana plants may be grown on any single-family dwelling residential property at any one time, regardless of the number of persons residing, either temporarily or permanently, at the property.
- (3) No more than 24 marijuana plants may be grown by a primary caregiver, or combination of patients and/or caregivers on any single-family dwelling residential property at any one time, except under the authority of a valid, Extended Plant Count Permit.
- (4) No more than twenty-four (24) medical marijuana plants may be grown by a patient, primary caregiver, or combination of patients and/or caregiver on any vacant, unoccupied, or non-residential property at any given time,
- L. Marijuana cultivation under this Ordinance shall not be for the use of any licensed Marijuana Establishment, as that term is defined in the Colorado Medical Marijuana Code and Colorado Retail Marijuana Code.
- M. It shall be unlawful for any person who is not licensed to sell marijuana. A caregiver may be reimbursed for the costs involved in marijuana production pursuant to C.R.S. 25-1.5-106.

2. Section 8 of Ordinance 1-2017 is hereby amended as follows:

Section 8. Provisions for Outdoor Cultivation of Medical and Personal Use Marijuana on Residential Property.

D. Cooperative, joint, collective, or other combined grows on a single parcel by more than one primary caregiver are not permitted. Cooperative, joint, collective, or other

combined grows on a single parcel by more than one patient are permitted, subject to the plant count restrictions in this Ordinance, and provided at least one of the patients engaged in the cultivation operation has a 50% or more fee-simple ownership interest in and resides on the parcel used for cultivation.

2. Section 9 of Ordinance 1-2017 is hereby amended as follows:

- Section 9. Cultivation of Medical Marijuana on Vacant, Unoccupied Property or Non-Residential Property. Cultivation of medical marijuana by a caregiver or one or more patients on vacant, unoccupied, or non-residential property is allowed, subject to the provisions of this Ordinance and the following requirements and restrictions:
- E. A primary caregiver for one or more patients with extended plant counts may exceed the 24 plant count only upon approval and issuance of a Fremont County Extended Plant Count Permit. A primary caregiver shall not cultivate, transport or possess more than thirty-six plants unless the primary caregiver has one or more patients who, based on medical necessity, have an extended plant count.
- F. Cooperative, joint, collective, or other combined grows on a single parcel by more than one primary caregiver are not allowed. Cooperative, joint, collective, or other combined grows on a single parcel by more than one patient are allowed, if at least one of the patients engaged in the cultivation operation has a 50% or more fee-simple ownership interest in the parcel used for cultivation.
- 3. Section 10 of Ordinance 1-2017 is hereby amended as follows:

Section 10. Extended Plant Count Permit (EPCP) for Medical Marijuana Only.

B.

- (3) The plant count shall be a minimum of 13 plants and a maximum of 99 plants.
- (10) Cooperative, collective, or combined patient cultivation is permitted, subject to the combined maximum plant count of 99. Each cultivator's plants shall be separated, with ownership readily identifiable.

4. General Provisions.

A. Retail/Recreational Marijuana for Commercial Purposes. The adopting of this Ordinance 1-2020, shall have no effect upon Fremont County Ordinance No. 1-2013, Prohibiting the Operation of Retail/Recreational Marijuana Cultivation Facilities, Retail/Recreational Marijuana Product Manufacturing Facilities, Marijuana Testing Facilities and Retail Marijuana Stores Pursuant to Article XVIII, §16 of the Colorado Constitution.

- B. Repealer. Any prior Fremont County Ordinances, Regulations, Resolutions, or Enactments regarding Residential Property Cultivation, Vacant or Unoccupied Property Cultivation and/or Caregiver Cultivation of medical or personal use marijuana that are inconsistent with the provisions of this Ordinance, specifically those provisions in Ordinance 1-2017 that are amended by this Ordinance are repealed and shall have no further relevance or effect after the effective date of this Ordinance 1-2020.
- C. Severability Clause. If any section, subsection, clause, or phrase of this Ordinance is for any reason held to be invalid, such holding shall not affect the validity of the remaining portions of this Ordinance.

5. Publication and Effective Date.

The foregoing text is the authentic text of Fremont County Ordinance No. 1-2020. The first reading and public hearing of the Ordinance took place on December 8, 2020. It was published in full in the Cañon City Daily Record on December 16, 2020.
