c. County Manager Report, Sunny Bryant, County Manager

County Manager Bryant reported the following:

2. John C. Fremont Library District update Representative: Tabby Selakovich, Director

Commissioner McFall explained that this is an understanding between Bureau of Land Management and Fremont County to work together on the potential expansion of the Martin Marietta Parkdale Quarry.

Commissioner Bell said that in the past the County has had these types of agreement with the Bureau of Land Management and they have worked out well. She said that it gives the County an opportunity for a larger voice. Commissioner Bell also said that the first step of this process is a public scoping which will begin in July.

The yard sales are community based with spaces sold to those wishing to participate. The application fee and surety bond will be waived. Events will be held at the parking lot area of the Goose Berry Patch located on the intersection of 6th Street & Colorado State Highway 115 in Penrose, Colorado. 2. Request: TUP 19-006 – Star Point STEAM Fair Request approval of a Temporary Use Permit, Department file #TUP 19-006 Star Point STEAM fair. Event is for early childhood (preschool) to explore Science, Technology, Engineering, Art, and Math. Numerous vendors and organizations will be in attendance. The date is June 15, 2019, beginning at 10:00 a.m. and ending at 2:00 p.m., excluding set up and tear down time. This is the first request. Representative: Kathleen Kennedy

Kathleen Kennedy said that this event was held last year at the Abbey field house. That event was held to test the water and see what the turn out would be for such an event. Ms. Kennedy said that it was well received and so Starpoint wanted to move the fair to their own property. Ms. Kennedy went on to say that the event is open to the general public. She said that the activities would be geared toward early childhood but anyone can participate. Ms. Kennedy said that this would be a free event.

Planning and Zoning Director Garrett gave a staff report stating that all the required paperwork had been filed and was in order. There was also a request to waive the surety bond.

Commissioner Payne asked why a permit was required since the event would be held on Starpoint property.

Ms. Kennedy said that since the event would be held outside and not during regular business hours, they thought it would be best to get a permit.

Commissioner McFall asked P & Z Director Garrett about the food truck that 4-H would have at the event.

Planning and Zoning Director Garrett said that it had been addressed and everything is good.
