- b. County Manager Report, Sunny Bryant, County Manager

County Manager Bryant reported that on Monday July 9, 2019 she met with the City of Canon City and the City of Florence. Later that same day, she and the Commissioners went out to Cotopaxi for the ribbon cutting of the Sheriff's substation. Ms. Bryant also reported that the Sheriff indicated that his office is at 92% staffed. She then went on to report that the Hayden Pass project is wrapping up. Ms. Bryant informed the Board that there have been four sites chosen, so far, for the EPA Brownfields project. She said those sites are Skyline Steel in Canon City, St. Cloud Hotel Canon City, Colorado Quarries Canon City, and the Baker property in Florence. Determination letters are being submitted for approval for other properties to the EPA.

Commissioner Bell wanted to let everyone know that she and Commissioner Payne would be leaving this week for a National Association of Counties Conference held out of state. She explained that since she serves on the Colorado Counties Inc. board of directors, she also serves on the larger national board of Agriculture and Rural Affairs. She looks forward to coming back with a lot more information. She feels that this is a great opportunity to advocate for local officials and citizens to find out more about what is happening on a national level.

Commissioner Payne wanted to take this opportunity to remind everyone that the draft Eastern Colorado resource management plan with the BLM will be held at the Abbey at 5:30 the evening of Tuesday July 10, 2019. He said that it is a public meeting where the community can voice their thoughts.

Commissioner McFall wanted to add to what Ms. Bryant said about the Sheriff Substation in Cotopaxi. He said that the lack of law enforcement on the West end of the County has been talked about since he has been in office. He applauds Sheriff Cooper and Captain Green for being able to staff the substation in Cotopaxi.

2. Resolution No. 20, authorizing the transfer of appropriated funds between the Self-Funded Insurance and the General Fund of Fremont County, Colorado, for the budget year ending December 31, 2019

County Manager Bryant said that at the end of each year we typically do a resolution to approve the transfers. However, the new auditors would like as many of those transfers as possible be done prior to year-end. This transfer is for the indirect costs that are transferred between the self-funded insurance into the general fund to help offset some of the costs associated with managing that program. The amount of \$30,966.00 is determined by our consultants that come in and do the cost allocation plan.

Commissioner Payne moved to approve resolution number 20; the transfer of appropriated funds (\$30,966.00) between the Self-Funded Insurance and the General Fund of Fremont County, Colorado, for the budget year ending December 31, 2019. RESOLUTION NO. 20, SERIES OF 2019
