The 40.28 acres site is located off County Road 69 in Canon City, near Highway 50 and is within the Agriculture Forestry Zone District.

c. SRU 20-006 Black Hills Energy North Penrose Station
Requesting approval of a Special Review Use, Department file #SRU 20006 Black Hills Energy Penrose Station for a substation, that will include a
115kV six-position ring bus for connecting two 115 kV line terminals, two
115/13.8kV transformers, one now, one future and two future 115kV line
terminals. The substation will also operate a 115/13.8kV 30/40/50 MVA
transformer and associated 3000-amp main bus switch gear enclosure to
improve reliability and electric supply in the Penrose area. The 22.43 acres
site is located off of K Street in Penrose, near Highway 115 and is within
the Agriculture Rural Zone District.

 Kinship Care Month Proclamation Representative: Tony Carochi, Department of Human Services

Tony Carochi, Department of Human Services, read a Proclamation for Kinship Care Month in Fremont County.

Mick Stumph, Department of Human Services, thanked the Commissioners for honoring Kinship Care month. He explained how important it is to try and keep children in a familiar home setting when at all possible.

Commissioner Bell agreed with Mr. Stumph saying how necessary it is for children to be in a familiar environment during what is an extremely stressful time in their lives. She, in turn, thanked Mr. Stumph and everyone at DHS for everything they do to help families.

 Proclamation for National Suicide Awareness Month in Fremont County in September 2020 Representative: Carie Canterbury

Carie Canterbury gave a brief explanation about the American Foundation for Suicide Prevention and how they use the funds raised to increase awareness and provide educational resources that advance the goal of preventing suicide. She said that this year the Out of the Darkness Experience will be held online Saturday September 12, 2020 at 10:00 a.m. at www.afsp.org/cotogether. Ms. Canterbury then read the Proclamation for National Suicide Awareness Month, September 2020, in Fremont County.

Commissioner Bell said that although this topic is very difficult to discuss it is very likely that everyone knows a family that has been affected by suicide. She thanked Ms. Canterbury and her entire group for the work they are doing to bring awareness to suicide prevention.

4. MS 20-004 Willow Street Subdivision Requesting approval for minor subdivision that includes a lot line adjustment for two properties located on Willow Street. The proposal includes two parcels, the first being 5.05 acres in size and the other being .5 acres in size. The proposal will result in three lots being platted, lot 1 will be one acre in size, lot 2 will be 3.55 acres in size, and lot 3 will be 1.06 acres in size. Representative: Kalem Lenard

Kalem Lenard said that he and his family have purchased the property from Mr. Lamborn and would like to subdivide the property to be used for possible farming and for building homes for his family.

Planning and Zoning Director Sean Garrett gave a staff report stating that the application is complete. He said that there are no waiver request and two contingency items. The first is a minor revision to the plat and the second is completed ratification release and consent forms.

Commissioner Payne moved to approve MS 20-004 Willow Street Subdivision request for a minor subdivision that includes a lot line adjustment for two properties located on Willow Street. Two contingency items are revisions to the plat and completed ratification release and consent forms. The proposal includes two parcels, the first being 5.05 acres in size and the other being .5 acres in size. The proposal will result in three lots being platted, lot 1 will be one acre in size, lot 2 will be 3.55 acres in size, and lot 3 will be 1.06 acres in size. Commissioner McFall seconded the motion. Upon Vote: Commissioner Payne, aye; Commissioner McFall, aye; Commissioner Bell, aye. The motion carried by unanimous consent.

 Appoint a new member to the Fremont County Airport Advisory Board to fill a vacant position with a term expiring October 1, 2022

Commissioner Bell said that a recently there were two vacancies to be filled on the Airport Advisory Board and that the Commissioners had interviewed three applicants for those positions. She said that all three of the people were highly qualified but, at the time there were only two positions available. Ms. Bell said that since that time another vacancy on the Airport Advisory Board has become vacant. She said that since the third interviewed applicant from the last round was qualified and had already been interviewed, it is the Board's decision to appoint Terrence Terrill to the Fremont County Airport Advisory Board with a term expiring October 1, 2022.

Commissioner McFall moved to appoint Terrence Terrill to the Fremont County Airport Advisory Board to fill a vacant position with a term expiring October 1, 2022. Commissioner Payne seconded the motion. Upon Vote: Commissioner McFall, aye; Commissioner Payne, aye; Commissioner Bell, aye. The motion carried by unanimous consent.
