- 1. Staff / Elected Officials:
  - a. County Manager Report, Sunny Bryant, County Manager
    - 9/14, Sunny attended the monthly Area Manager's luncheon. These are always a great way to see what's going on in other communities.

- 9/20, Sunny and the Commissioners had a work session where they discussed a proposal for a new hotel in Fremont County. They also discussed the possibility of doing some mining in a pit that is leased by the County.
- 9/21, Sunny attended the Penrose Chamber Breakfast where she learned that the Wells Fargo in Penrose will be closing.
- Everything concerning the 2018 budget is coming together and there will be a rough draft presented to the Commissioners by October 16<sup>th</sup>.
- The County is working with the Historical Fund Grant to help cover the cost of a roof replacement on the County Administration Building.
- The County is also working on a FEMA grant to help cover the cost of flooding mitigation after the Hayden Pass fire.
- A DOLA grant is in the works along with an Underfunded Courthouse grant to help cover the costs of renovations at the Judicial Building.
- They are working on another DOLA grant to help cover the costs of repairs on one of the tunnels on Phantom Canyon.
- On 10/21, the County will be offering a mass flu clinic from 9:00-12:00
- The security system upgrade at the Sheriff's Department is moving along. There have been a few issues but the contractors are doing a good job keeping the project moving forward.
- b. Sales & Use Tax Report, Sunny Bryant, County Manager

County Manager Bryant reported that the retail sales tax collected for the month of July was \$441,805 which is up \$29,356 and YTD is up \$154,443. The auto use tax collected for the month of August was \$102,167 which is up \$5,946 and YTD is up \$34,206. The construction use tax collected for August was \$25,316 which is down (\$6,845) and YTD is up \$30,393. The lodging tax collected for the month of July was \$5,243 which is down (\$9,004) and YTD is up \$4,536. The Sheriff retail sales tax collected for the month of July was \$ 294,536 which is up \$19,571 and YTD is up \$102,963. The Sheriff auto use tax collected for the month of August was \$68,111 which is up \$3,964 and YTD is up \$22,864. The Sheriff construction use tax collected for the month of August was \$16,670 which is down (\$4,771) and YTD is up \$18,645.

1. Memorandum of Understanding with Colorado Department of Local Affairs - University of Colorado Denver, Colorado for Community Development to prepare a design of a Search and Rescue Building

**County Manager Bryant** explained that in order to accurately come up with the cost of a building for the Search and Rescue team, they will first need to reach out to have a design made. The cost of having the University of Colorado students draw up the plans for a building is \$4,125. The County will pay \$2,475 and DOLA will pay the remaining \$1,650.

**Commissioner Payne** moved to approve the Memorandum of Understanding with DOLA and the University of Denver. Commissioner McFall seconded the motion. Upon Vote: Commissioner Payne; aye, Commissioner McFall, aye; Commissioner Bell, aye. The Motion Carried.

2. Authorization of the Chairman's Signature on an Airport Construction Agreement with Electrical Excellence Enterprises

**County Manager Bryant** explained that the Board already awarded the bid to Electrical Excellence Enterprises for this construction. This is an agreement to pay \$123,579 for the lighting on the runway.

**Commissioner McFall** moved to approve authorization of the Chairman's signature for the Airport Construction Agreement. Commissioner Payne seconded the motion. Upon Vote: Commissioner McFall, aye; Commissioner Payne, aye; Commissioner Bell, aye. The Motion Carried.

3. Five-Year Professional Services Agreement between Fremont County and Armstrong Consultants, Inc. for Fremont County Airport Improvements

**County Manager Bryant** explained that the current agreement between Fremont County and Armstrong Consultants is expired. The County sent out a request for bids and the only company that sent in a bid was Armstrong Consulting.

**Commissioner Payne** moved to award the bid for professional services to Armstrong Consulting, a five year agreement. Commissioner McFall seconded the motion. Upon Vote: Commissioner Payne, aye; Commissioner McFall, aye; Commissioner Bell, aye. The Motion Carried.
