Commissioner McFall spoke about the low vehicle inventory.

Commissioner Bell mentioned her personal bias against marijuana in most instances but said the Board found no justification in denying the request.

Commissioner McFall added that the Board is making a justified decision having taken a lot into consideration.

Commissioner Grantham indicated that he shares similar sentiments about marijuana.

Commissioner Bell noted that there is no need to try to sway the Commissioners' views on the matter as personal feelings are what they are.

 Proclamation for Kinship Month Representatives: Barry Acton, Tonia Sutton, and Tony Carochi Tonia Sutton, Family Services Program Administrator spoke about the work done by Fremont County Social Services to find care for children within their families. She then read the Kinship Month Proclamation.

Amy Maroni, Kinship Case Worker introduced herself to the Board.

Commissioner Bell talked about the shortage of Foster Care Families in Fremont County and thanked Fremont Social Services for their hard work.

Commissioner Grantham also showed appreciation for the work they do.

Commissioner McFall moved to proclaim September 2022 Kinship Care Month in Fremont County. Commissioner Grantham seconded the motion. Upon Vote: Commissioner McFall, aye; Commissioner Grantham, aye; Commissioner Bell, aye. The motion carried by unanimous consent.

2. Request TUP 22-010 Rocky Mountain Trials Association for a motorcycle trials event conducted on private land located at 2074 County Road 9, Canon City. The event is scheduled for October 23, 2022 from 8:00am to 6:00pm.

Representative: Dan Wickersham

Dan Wickersham explained that the last event was cancelled due to 16" snow. He added that the current request is for a small event of about 30 people and spoke about there being portable toilets and possibly wash-basins.

Commissioner Bell requested that Mr. Wickersham explain the event.

Mr. Wickersham explained the technicalities of the event.

Commissioner Bell asked whether there would be food onsite.

Mr. Wickersham said there will be no food onsite.

Planning & Zoning Coordinator Adamic gave the staff report and mentioned a waiver request for the cash-bond.

Commissioner Grantham pointed out that the staff report suggests the presence of a portable sink but does not require it.

Commissioner McFall said they seem self-sustaining.

Mr. Wickersham put in that it is not a spectator event.

Commissioner Bell pointed out that during their last event was the only time that year the County had experienced 16" of snow.

Mr. Wickersham insisted it was the only time in years.

Commissioner Bell invited anyone from the public who would like to speak on the event. There were none.

Commissioner McFall claimed the trials are very impressive.

Mr. Wickersham spoke about the automotive skills that the competitors possess.

Commissioner McFall added that the sport is enjoyable to watch.

3. Design-Build Agreement with Corsentino Construction for the Pathfinder Park Pavilion Project

Commissioner McFall said they awarded the bid in June to build the Pathfinder Park Pavilion and spoke about the project and its contract.

Commissioner Bell asked whether there was a timeframe set.

Commissioner McFall explained that times will be discussed at the meetings.

Commissioner Bell asked whether there is a cost assigned on the contract.

County Manager Bryant clarified that it comes to roughly \$1.9 million, and they have contracted about 3 months for design and 5 months for construction.

Commissioner Bell asked her to explain where the finances for the project came from.

County Manager Bryant explained that funds were derived from interest savings and savings from freed-up accounts through the COP refinance.

Commissioner Bell imparted that the total anticipated cost of the project is \$1,915,883.00 subject to adjustment as provided.

Commissioner McFall moved to approve the Design-Build Agreement with Corsentino Construction for the Pathfinder Park Pavilion Project. Commissioner Grantham seconded the motion. Upon Vote: Commissioner McFall, aye; Commissioner Grantham, aye; Commissioner Bell, aye. The motion carried by unanimous consent.

4. Adoption of the 2023 Fremont County Holiday Schedules

County Manager Bryant explained that the County schedules days off based on standard recognized holidays and pointed out that there is a holiday schedule for both 10-hour workdays and 8-hour workdays.

Commissioner Bell informed the public that the Board received a letter from Mr. Rupp, who has done a great job as a member of the Board.
