ADMINISTRATIVE/INFORMATIONAL

- 1. Staff / Elected Officials:
 - a. County Manager Report, Sunny Bryant, County Manager

County Manager Bryant said that on September 5th, she, Commissioner McFall, County Engineer Don Moore and several potential engineers visited the Hayden Pass project. Bids are due on September 19th. County Manager Bryant said that the bids will be reviewed and she hopes to have a recommendation at the next meeting for an engineer.

County Manager Bryant said that she and the Commissioners met with representatives from the City of Florence on September 10th.

County Manager Bryant also said that she was starting the 2019 budget process. She has been compiling requests submitted by all departments. She plans to start meeting next week with the Commissioners.

Commissioner Bell wanted to congratulate the City of Florence on the annual Tour de Coal Towns in conjunction with Coal Creek, Rockvale and Williamsburg. She said it was a great Celebration.

Commissioner Bell also wanted to inform the public that Pioneer Day will be held in Florence, on Saturday, September 18, 2018. She encouraged everyone to attend.

2. Citizens who wish to address the Commissioners on a matter not scheduled on the agenda

George Storey said that on this Patriot's Day we should all work together. He has heard that Syria may be considering a chemical attack. He feels that chemical warfare shouldn't be used on humans.

Joshua Hinton said he wanted to address the odor permeating the Lincoln Park neighborhood. He indicated that emails had been sent to the Commissioners, Sheriff Martin and Department of Public Health Director Emma Davis, asking, "Is our neighborhood in danger?" Mr. Hinton said the he spoke with Sheriff Martin on Saturday. His understanding of what Sheriff Martin said was that the Sheriff's Department is more concerned with the ammonia supposedly being held at Cotter. Mr. Hinton is rather alarmed with that statement. He indicated that Commissioner Payne had visited the Cotter site along with code enforcement and did not believe that was the source of the odor. Mr. Hinton also said that representatives from the Fremont County Department of Public Health as well as representatives from the State Department of Public Health have visited Cotter and they do not feel that is the source of the odor either. It is the belief of Mr. Hinton that this is a drug related problem. Mr. Hinton said there are scouts out on the streets at night to report when law enforcement enters the area. People walking around that appear to be high, blatant daylight theft and he personally witnessed a vapor cloud pouring out of a residence that stopped as soon as 911 was called. He would like to know if this is a possible major environmental issue or whether there is some kind of illegal activity. He is asking on behalf of the residents of Lincoln Park, that Fremont County make an official statement on the current conditions of the Lincoln Park neighborhood.

Commissioner Payne said that he also lives in that neighborhood and also gets woken up at night because of the odor. Commissioner Payne said that this is a well-established problem and that the county has people trying to find a solution.

Sheriff Martin said, in response to Mr. Hinton, that he was not stating anything to be fact when they spoke on Saturday. Sheriff Martin said that his department has given more resources in the past month toward this issue than anything else that has been going on in the community. Sheriff Martin said that nothing is being ruled out. He stated that the fire department, the county code enforcement, county health department, and state health department have all been working towards finding a solution. Sheriff Martin said that although there is no known cause, the issue continues to be investigated.

1. Resolution in Recognition and Appreciation of the Vital Emergency Services Provided by First Responders in Fremont County, Colorado

Commissioner Bell recalled the day 17 years ago when the World Trade Center was destroyed in a terrorist attack. She said that act changed the face of America. Commissioner Bell also said that the good thing that came from this tragedy is our appreciation for first responders.

Commissioner Bell read the resolution recognizing the First Responders across Fremont County. Fremont County appreciates the First Responders that have committed themselves to a life of serving and helping others with professionalism and calm assurance in times of greatest need.

 Approval of an Employee Assistance Program/Work-Life Contract with Health Management Systems of America Representative: Tammy Childs, Fremont County Human Resources Director

Tammy Childs, Fremont County Human Resources Director, said that it has been recognized by the Commissioners that in addition to our annual health fair, that we have a need for an official program to help our employees with things from financial difficulties to traumatic events either at work or in their personal life. Ms. Childs said that she and Emma Davis, Public Health Director, set out to find someone to give us an employee assistance program. Ms. Childs said that the County has entered into a contract with Health Management Systems of America effective October 1, 2018. Ms. Childs said that County employees will be able to make contact with a counselor on the phone or up to 3 face to face visits.

Commissioner Bell feels like Fremont County has done a lot in terms of health events for the employees. She said that this is the next step in that assistance. Commissioner Bell said that up until now it has been geared more towards physical health but this adds a layer of mental health support that may be helpful to some, if not all, employees.

Commissioner Bell moved to approve the Employee Assistance Program/Work-Life contract with Health Management Systems of America. Commissioner McFall seconded

RESOLUTION NO. 33, SERIES OF 2018

RESOLUTION DENYING RECONSIDERATION OF REQUEST FOR MODIFICATION OF MEDICAL MARIJUANA OPTIONAL PREMISES CULTIVATION LICENSE

OPC 14-011 PURE MEDICAL, LLC, MODIFICATION OF PREMISES (#2) 440 8TH STREET, PENROSE, CO

WHEREAS, on October 25, 2016, the Board of County Commissioners adopted Resolution No. 22, Series of 2016, enacting Amended Fremont County Medical Marijuana Business Licensing Regulations within the unincorporated areas of Fremont County; and

WHEREAS, on May 1, 2018, Pure Medical, LLC submitted an application for modification of a Medical Marijuana Business License, requesting addition of a 90' X 60' building to the licensed premises, which presently contains various structures and an outdoor cultivation area; and

WHEREAS, following proper public notice, as required by the Business Licensing Regulations, the Board of County Commissioners, as the Local Licensing Authority for Medical Marijuana Business Licensing, held a public hearing on July 24, 2018, for consideration of the Modification Application; and

WHEREAS, on August 14, 2018, the Authority adopted and approved Resolution 28, Series of 2018, denying the request for modification of premises by Pure Medical; and

WHEREAS, on August 23, 2018, Pure Medical submitted a formal Request for Reconsideration of the denial set forth in Resolution 28, Series of 2018; and

WHEREAS, the Authority has no legal or regulatory obligation or requirement to reconsider a decision on a medical marijuana business license application; and

WHEREAS, the Request for Reconsideration presents Pure Medical's argument regarding the findings of the Authority, but the Authority is disinclined to engage in such an argument under the guise of reconsideration.

THEREFORE, the request for reconsideration of the Authority's denial of Pure Medical's Request for Modification of Premises (OPC 14-011) is denied. This Resolution shall constitute final, formal action for purposes of judicial review.
