He also knows that there is a lot of things that need to be repaired from the last four years.

**Kevin Mahmalji** from the Florence Reporter wanted to personal invite the commissioners, elected officials, and staff to attend a public convening concerning the animal control issue that the community is experiencing. Mr. Mahmalji said the goal of this discussion is to create a resource guide for citizens for whenever an issue of animal control comes up.

### **UNFINISHED BUSINESS**

1. Consideration and adoption of Fremont County Zoning Resolution. Dan Victoria, Planning & Zoning Director

Planning and Zoning Director Victoria said that all the significant changes were discussed at the special meeting. The changes made since the last meeting were a result of a workshop with the commissioners and the others. Some of the changes include removing the definition of Special Mobile Machinery, adding the definition of an Agricultural Building, and clarified the parking requirements in the R1, R2, and R3 zone districts for agricultural uses. He also said that language was added to non-conforming uses when it comes to restoration, and solid waste disposal sites and facilities, in regard to materials that emit radiation in excess of naturally occurring background levels. Staff also removed all references to Colorado Department of Transportation having a 500ft jurisdiction in the regulations to clarify and align with CDOT's regulations.

Commissioner Bell moved to adopt Fremont County zoning Resolution No. 35 repealing the Fremont County Zoning Resolution adopted January 15<sup>th</sup>, 2009, together with all amendments and adopting a new Fremont County Zoning Resolution that will take effect December 1<sup>st</sup> of 2024. Commissioner Grantham seconded the motion. Upon Vote: Commissioner Bell, aye; Commissioner Grantham, aye; Commissioner McFall, aye. The motion carried by unanimous consent.

2. Consideration and adoption of Official Fremont County Zoning Maps Resolution.

Dan Victoria, Planning & Zoning Director

Planning and Zoning Director Victoria said the main change is to the consolidation of Zone Districts and removing a classification. He said the department worked very closely with GIS, asking them to redraft the maps to match the zoning changes as well as using different colors in hopes the lines and areas are easier to see and eliminate property conflicts. Director Victoria also explained that when there is a zone change a new zoning map must be adopted.

Commissioner Grantham moved to adopt Resolution No. 36 reappealing the official Fremont County zoning maps and adopting the new official Fremont County Zoning Maps to be implemented December 1<sup>st</sup> concurrently with out Zoning Resolution No. 35. **Ms. Brott** said that the two boys that are going to be adopted have been waiting two years for this day. She said they have been in the same home the whole time, and this is the same family's fifth adoption including one of the boys' biological sister.

Commissioner McFall asked how many children are up for adoption in Fremont County.

Ms. Rall said there are currently 11 children that need to be adopted including a family of five.

### 3. TUP 24-009 Venue at Oak Creek

The applicant is requesting a Temporary Use Permit to host private, indoor events such as weddings, reunions, memorials, holiday parties, meetings, celebrations, banquets, birthday parties, classes and art presentations/ showcases. Date of approval to January 1, 2025. The applicant states the events can be held 7 days a week. Events can have a start time of 10am and end at midnight with the exception of 1/1/25, which will end at 1am. The duration of each event is dependent on the type of event. Located at 800 North Frazier Avenue, Florence CO 81226. Applicant: Amy & Jason Hilterbran

Mrs. Hilterbran said that her and her husband 14 months ago invested in the property located at 800 North Faiser Avenue. She said it has been an extensive renovation and remodel project which spans a 4,000 square foot barn that is now an event center. The change of use for the building is done as well as the certification of occupancy has been issued which has a limit of 225 people. The purpose of this venue is to host reunions, birthday parties, weddings, memorials, and small banquets. Mrs. Hilterbran also explained that the reason or the variations in hours of operation is because that will mainly be determined by the clients who rent the venue. For example, if someone rents the venue for an evening wedding, after the ceremony, reception, dinner and drinks it most likely be midnight. They anticipate larger events only taking place on the weekend when the school nearby is not in session. The only events anticipated to happen during school hours are small meetings with a total of 20 to 25 people occurring about once a month. Mrs. Hilterbran went on to explain that they will continue to seek TUP's until they file the special review use permit, and they are not able to file for one until they officially buy the property because they are currently only in a lease and do not want to continue investing money into the property until it is officially theirs.

**Planning and Zoning Director Victoria** began the staff report by saying the applicants are asking for a TUP to be able to host weddings, reunions, memorials, holiday parties, meetings, celebrations, banquets, birthday parties, classes, art presentations, and showcases. The permit duration will be until January 1st, 2025. The hours of operations will be seven days a week with an open time of 10:00am and close time of midnight except for New Year's Eve which will end at 1:00am. The water is from the Public Water Supply City of Florence for drinking and other services. The Colorado Department of Public Health and Environment have no concerns they just ask that all caterers are appropriately licensed. The Fremont County Sanitation District will handle all things sanitation. The Florence Fire Station number 2 will respond to any emergency calls, the Chief Bill Ritter approved the fire plan that was submitted. The department received five letters from surrounding neighbors in support of this venue opening officially for business. Staff from planning and zoning requested comments from various review agencies including Fremont County Department of Transportation, Engineering, Environmental Health, Fire Protection, Sheriff's Department, and Emergency Management. The applicants are properly insured so the department is not requesting any conditions or contingencies. The applicants are requesting a wavier of the surety bond. The only concern the department is the fact of the noise ordinance in place for the City of Florence, although the property is not in the city limits and isn't enforceable the property is adjoined on two sides to properties that are inside the city limits. The applicant has expressed the

willingness to comply and that all noise pertaining to the active event will stop by midnight. Director Victoria said that the application follows the Fremont County Zoning Resolution, and the department is recommending approval provided the commissioners wave the surety bond per the applicant's request. **Sue Tierney** said she is resident of Cañon City and a Merchant President for the association in Florence as well as being on the Executive Board of Chamber of Commerce, so she is speaking on behalf of those agencies in support of this TUP.

**Commissioner Bell** asked if they would provide music for the outdoor spaces.

Mrs. Hilterbran said she anticipates in the summer months that some events will want to fully utilize the outside space with lights, music, etc. She also explained that the event center sits 180 feet back from the road and has two other buildings on either side as well as a decimal reader at the front gates to monitor the noise level.

**Commissioner Grantham** requested clarification on where they are at in the process of buying the property and if they are prepared to file the SRU once the property is bought.

**Mrs. Hilterbran** said they are negotiating the acquisitions terms as they speak. They are anticipating the acquisition to be finalized in 2025. Regarding the SRU she said that have already gathered all the paperwork and finished the drainage study, the site plan, and they have been in communication with CDOT.

**Commissioner Bell** asked County Attorney Bellas if they are legally allowed to set different end times depending on the day of the week for TUP's and if so, would that be a condition they would have to set.

**County Attorney Bellas** said that the board has the discretion to specify end times for different days.

**Commissioner Grantham** asked if they expect to submit the SRU application by January 1<sup>st</sup>.

**Mrs. Hilterbran** said no they expect to ask for at least one more extension of the TUP. She also explained that 14 months ago when they entered the lease, they were under the impression that all the correct permits were pulled and the projects were then inspected and it was a viable event center, they were unaware that all that information was false.

**Commissioner Bell** moved to approve Temporary Use Permit 24-009 for the Venue at Oak Creek for events which can be held seven days a week starting at 10:00am. This motion includes an end time of midnight for Fridays and Saturdays only, 10:00pm for Sunday through Thursday event except for New Year's Eve with an end time of 1:00am. This motion also includes the wavier of the surety bond and the end date of the TUP being May 11<sup>th</sup>, 2025. Commissioner Grantham seconded the motion. Upon Vote: Commissioner Bell, aye; Commissioner Grantham, aye; Commissioner McFall, aye. The motion carried by unanimous consent.

### PUBLIC HEARING SCHEDULED 9:30 a.m.

1. Proposed 2025 Fremont County Budget

Budget and Finance Officer Shawn Sutton presented the proposed budget. Mr. Sutton began the presentation with an overview of a decrease in revenue in Assessed Property Valuation, Social Services, Retail Sales Tax, and Auto Use Tax Collection. Some of the expected expenses include an increase in the salary scale and entry level pay. Mr. Sutton explained that they are plans to continue making improvements in all county owned buildings, with hopes that some funds will come from grants. The county is now funding long term disability for all county employees on the other side of things, the health insurance rate has increased 4.4%. The American Resue Plan Act is federal funding that the commissioners decided to treat the full amount as lost revenue enabling the funds to be used for government services that the treasurer's office allocates. This funding has been spent on Special Districts, churches, non-profits, and small grants for local businesses. In the fiscal year 2025 there are Fremont County projects that are expected to be completed, including judicial building improvements supported by grant money. Several departments are needing equipment and vehicle upgrades, as well as the sheriff's department getting new carpet, key fobs, and other miscellaneous things. Mr. Sutton goes on to explain the percentages of where Fremont County's revenues come from, 28% sales and use tax, 21% intergovernmental revenues, 14% internal transfers, 12% property taxes, and a few other miscellaneous sources. These funds will then get separated again into various departments such as 30% to general funds to take care of administrative duties, 20% goes to the sheriff's department, 17% to social services, 9% for road and bridge, the department of health gets 2%, and the airport fund receives 3%. Mr. Sutton said that if anyone in the community would like to view or have a copy of the draft budget, they can view it on the website or come into the administration building.

**Commissioner McFall** – opened the public hearing at 10:51 am.

**Commissioner McFall** said they have tried helping the citizens by lowering the property taxes by half a mil. He also said they have been weaning the county from using the PILT levy, this was due to the fact that it was never a guarantee that the payment would be received. Now that money goes to things like bridge repairs.

**Commissioner McFall** reminded the audience that is an open public hearing, and anybody is welcome to express their opinion or ask questions.

**Commissioner McFall** – closed the public hearing at 11:01 am.

**Commissioner McFall** adjourned the meeting at 11:02 am.
