#### **NEW BUSINESS**

1. Closure of the Fremont County Administration Building and the Garden Park Building on December 14th at 2:30 p.m. for the Annual Administration Christmas Party

**Clerk Barr** explained that historically, the Clerk's Office closes at 2:00 because the office has to wait on all customers who are in the door by 2:30 plus balance after that.

**Commissioner Payne** moved to approve the closure of the Administration Building and the Garden Park Building at 2:30 and the Clerk's Office at 2:00 on December 14<sup>th</sup> for the Annual Administration Christmas Party. 3. First Reading of Ordinance No. 1 Series of 2017; An Ordinance to Regulate the Cultivation of Marijuana on Residential Properties; in Residential Structures; in Accessory Structures on Residential Property; on Vacant or Unoccupied Land; and on Non-Residential Property and Requiring Registration of Caregivers. Repealing and Replacing Ordinances 2016-1 & 2016-2

Attorney Jackson explained that Section 6 is general provisions for indoor or outdoor cultivation of medical and personal use marijuana on property in unincorporated Fremont County. Section 7 is provisions for indoor cultivation of medical and personal use marijuana on residential property. Section 8 is provisions for outdoor cultivation of medical and personal use marijuana on residential property. Section 9 has some new provisions and section 10 is entirely new. (See the attached Ordinance)

**Clint Robertson** asked what specific requirements there are concerning marijuana waste.

**Attorney Jackson** said the requirements will vary and will be specific to the property.

**Clint Robertson** asked about section 10 (c) (3) and how this would affect people without septic.

Attorney Jackson said it would depend on whether the property was occupied or not.
