PUBLIC HEARINGS

Proposed 2023 Fremont County Budget
 Representative: Shawn Sutton, Budget & Finance Officer

Commissioner Bell opened the Public Hearing at 10:04 a.m.

Officer Sutton gave the report on the 2023 Proposed Budget, which can be found in its entirety at www.fremontco.com.

Commissioner Bell pointed out that about half of the ARPA Fund expenses up to date went towards Special Districts and to the grant program for small businesses, non-profits, and churches.

Commissioner Grantham said the County may soon have a page online to show how the funds have been spent.

Officer Sutton continued the report.

Commissioner McFall mentioned that some of the ARPA Funds are also going to parks.

Officer Sutton continued the report.

Commissioner McFall clarified that PILT (Payment in Lieu of Taxes) are moneys from the Federal Government for public lands that the County is not able to collect property tax on.

Officer Sutton continued his report and informed the public that the hearing for the adoption of the 2023 Fremont County Budget will be on December 19th. He added that there is a paper copy available in Rm 101 of the Fremont County Administration Building.

Commissioner Grantham pointed out a mistyping in the date on the last slide. He added that the budget adoption will take place on a Monday.

Commissioner Bell relayed that the budget process this year was mostly seamless, although there was a transition. She described that the one issue with the budget had nothing to do with changing personnel, but with the cyber-attack. Commissioner Bell then recognized Officer Sutton's hard work.

Commissioner McFall informed the public that the Construction Use Tax that was mentioned was removed to avoid double tax when Retail Tax is collected. He suggested that demand grows quicker than money does, so making a budget can be difficult then mentioned keeping an eye on retail sales as the supply chain may worsen.

Commissioner Grantham expressed gratitude toward Officer Sutton for his work. He elaborated on the conservative approach the Board takes on budgeting. He spoke about the current difficulty for those in both the Public Sector and Private Sector to keep employees. Commissioner Grantham then explained the use of ARPA Funds to make up for some necessary costs, including costs on equipment and vehicles for FCDOT and the Sheriff's Office.

Commissioner Bell invited public to speak on the proposed budget. There were no public comments.

Commissioner Bell closed the Public Hearing at 10:32 a.m.

Commissioner Bell noted that it is non-action item.
