2. Award Acceptance Notice – Grandview Avenue Bridge Representative: J. Bunderson

**County Engineer Bunderson** said the county has received five bids from contractors to replace the Grandview Avenue Bridge, four of the bids were well within range of each other so the low bid by Siete Inc. reflects the true cost of the project. Mr. Bunderson asks the County Commissioners of Fremont County to award them the bid for \$3,115,704.00.

**Commissioner Bell** asked Mr. Bunderson what the timeline is for this project; beginning to end.

**County Engineer Bunderson** answered that the notice to proceed should be around the first of May and the contract states the work is expected to be done in six months which would be the end of October or beginning of November.

**Commissioner Bell** moved to approve the bid of the Grandview Bridge replacement project to Siete Incorporated at the amount of \$3,115,704.00, the motion does include all the associated signatures as requested. **Commissioner McFall** opened the public hearing at 9:35am.

# 1. ZC 23-003 T-K Processing

The applicant consultant, George Hall with Crown Point Land Services, on behalf of T-K Processing, is requesting to rezone 2.27 acres from Agricultural Estates to industrial. The application also includes a Final Development Plan and Special Review Use Permit to allow for a slaughterhouse (meat process slaughtering operation) located at 1906 and 1910 North Street.

Consultant: George Hall

Applicant: Jeffrey Kessler & Zach Tracy

**Mr. Hall** said the request is for a meat processing plant at 1906 and 1910 North Street where they are putting two lots together. The plan is to move the 98 square foot building to be in compliance, a contingency was to put curbing around the leach field to avoid someone backing over it, but they are requesting a rock barrier instead.

**Mr. Tracy** said it is going to be a locally owned and operated slaughterhouse/meat processing plant. The intention is to provide a service for residents who raise their own animals and then later need assistance in processing the animal.

**Mr. Kessler** said in addition to that they are also looking forward to hiring around 10 employees. He said not only are we offering Fremont County a product but also a service that this community desperately needs. They also intend to continue cleaning up and improving the area.

**Director Victoria** began his staff report by introducing the property and stating the 2.27 acres of land is currently zoned as agricultural and the request is to change it too industrial. Included is a final development plan and special use permit to allow for the slaughterhouse meat processing operation, the proposed development would include a slaughterhouse operation to be contained within an existing 2,619 square foot building. A holding pen in the Southeast corner of the property. A 900-foot cooler to be constructed. A 1,159 square foot manufactured trailer is proposed to be used as an office space. An 831 square foot manufactured trailer would be dedicated as a watchman's quarters. Behind the processing facility there are two septic tanks, a leach field, and 12500 gallon holding tank. 11 parking spots are proposed with a delivery/pick up trailer backing area to be surfaced with six-inch gravel. Contingencies include applying for a non-conforming use status application because once the land is changed to industrial the location of the watchman's quarters would not be in compliance. The 98 square foot shed will need to be moved. The final development plan indicates a sign for the business, the planning commission allows a 32 square foot sign, no higher than six-foot, lighting is allowed but recommends down lighting to reduce light pollution. The requirements for the parking lot shall be asphalt or concrete unless waived by this board, the rest of the lot should be six-inch gravel that is graded.

**Keith Leonhardt** is with Local Mountain Outfitters. He said they always have a problem finding wild game processing, and he has been there for 12 years. He stated he has known the family for a long time;

they do good business, and the quality is excellent. He believes it would be very good for the community because locals always have to take their business elsewhere so if this business were to open people could stay local.

**Lindsay Camper** said that their business requires a lot of beef to be processed. She believes last year they took approximately \$25,000 dollars out of county because there wasn't a processing establishment available, so she wanted the commissioners to know this business is very much needed in the community.

**Commissioner McFall** – closed the public hearing at 10:07 am.

Commissioner Bell moved to approve zone change 23-003 T-K Processing, the request to rezone 2.27 acres from agricultural estates to industrial. This application does also include a final development plan and special review use permit to allow for the processing/slaughtering operation located at 1906 and 1910 Noth Street. Included in this motion are seven contingencies as presented within our packet, with the exclusion of the continuous curb that language shall be changed on contingency number five to read a physical barrier as deemed appropriate by the department. This motion also includes the acceptance of the recommended findings of fact, there are eight of them on the same page and our packet on page 12 it also includes the payment of the annual roadway impact fee, also a waiver for the hard surfacing except for the ADA spaces. Commissioner Grantham seconded the motion. Upon Vote: Commissioner Bell, aye; Commissioner Grantham, aye; Commissioner McFall, aye. The motion carried by unanimous consent.

2. MS 24-001 Hilgren

Requesting approval for minor subdivisions that will create a total of 2 lots.

Lot 1: 23 Acres 1,002,095 square feet

Lot 2: 6.00 Acres 261,114 square feet

The subject property is located in the Agricultural Rural Zone District, on County Road 95,

in Florence

**Mr. Koch** said the property is located Southwest of Florence on County Road 95, it's 29 acres, it has an existing single wide house on it, it is intended to stay on the six-acre lot. They are requesting a variance since the lot does not meet the width requirement. The owners of lot one are planning on building a house and owning horses.

**Director Victoria** said the applicant is requesting a deferment of percolation test until development and the applicant is requesting deferment of a drainage plan. The County engineer has reviewed the drainage report and stated that one is unwarranted at this time because there will be no change to the drainage discharge. Fremont County Department of Transportation requires the applicant to submit a driveway access permit for the new lot and in reviewing the map of the existing home there are two access points that will be required to submit access permits. Planning and zoning recommend the following three deferments: the drainage plan and report for lot number one at the time of development and address

issuance application at the time of development. There is one contingency request that is the driveway access permits for both access points be applied for on lot two.

3. TUP 24-002 RMTA Club Trials Event

Applicant: Danny Wickersham

**Mr.** Wickersham said it is a local club event, they expect 20 to 30 vehicles, most people carpool. There will be no spectators. Porta potties will be delivered next week which is a week prior to the event from Twin Enviro. Many of the riders are EMS, and all the bikes will have spark arresters.

**Director Victoria** said this is the third year they have applied and that after this it will only be administrative approval. Riders will supply their own food and water, no vendors, two chemical toilets, pack in and pack out policy for trash.

**Commissioner Bell** moved to approve temporary use permit 24-002 RMTA Club trials event to be held on April 21<sup>st</sup> at the Stock Ranch, it is not a race and is not expected to have any spectators located at 1790 Red Canyon Road it includes the waiver of the Surety Bonds well as approval of chemical toilets. Commissioner Grantham seconded the motion. Upon Vote: Commissioner Bell, aye; Commissioner Grantham, aye; Commissioner McFall, aye. The motion carried by unanimous consent.

4. Fremont County District Attorney's Office Attorney's Fees Reimbursement Request

Attorney Bellas said the Fremont County finance office received an invoice from the District Attorney's office on April 1<sup>st</sup>, the District Attorney's office is not funded by the county or by any system of invoicing it is in fact funded by annual appropriation. This invoice will still be treated as a request for reimbursement of expenses incurred in the discharge of official duties for the benefit of the county as is contemplated in chapter 20 Article 1 part 3 of the revised statute. The invoice was for \$9,262, Attorney Bellas requested supporting documentation to review whether the amount claimed was appropriate under both statute and the case law interpreting the statute. It has been determined that only a portion is reimbursable. One attorney's costs were not reimbursable at all. The other attorneys were partially reimbursable costs totaling \$2,106, under Colorado law Fremont County would be responsible for its proportional share based on population that amount would be \$1,121.66 or 53.26% of the total reimbursable amount.

**Commissioner Grantham** asked if Attorney Bellas could explain in more detail what is subject to reimbursement under Colorado law and what isn't.

Attorney Bellas said the District Attorney's Office is entitled to reimbursement for expenses in the discharge of the official duties of the office for the benefit of the county. The expenses claimed were mostly attorney fees and costs associated in defending professional misconduct claims. The Colorado Supreme Court basically says that any expenses incurred in the defense of one of these claims, if found exonerated of all charges, then those charges must be reimbursed by the county. If the expenses are incurred for something else other than a claim that's not related to doing the duties of office or if the claim results in a finding of misconduct it is not reimbursable.

**Commissioner Grantham** moved to approve the reimbursement to the office of the district attorney in the amount of \$1,121.66 which is the Fremont County portion of the \$2,106. Commissioner Bell seconded the motion. Upon Vote: Commissioner Grantham, aye; Commissioner Bell, aye; Commissioner McFall, aye. The motion carried by unanimous consent.
