1. Introduction of Mike Cafasso, CEO of St. Thomas More Hospital of Canon City and St. Mary Corwin Hospital of Pueblo

Mr. Cafasso said he wanted to introduce himself to the community that he is now the permanent CEO at St. Thomas More Hospital. He said the hospital is doing very well in quality and financially. He wanted to explain why the name of the hospital is slightly changing. Catholic Heath Initiatives and Dignity Health merged to create the largest Catholic Healthcare System in the country, containing 140 plus hospitals. The name will remain St. Thomas More, Common Spirit will just be added in front of it.

4. LLA 24-003 Bartelmay

Requesting lot line adjustment 1919 Arnold Drive, Cotopaxi, CO 81223 Representative: John & Lynn Bartelmay

Mr. Bartelmay said he has 10.88 acres that's in the shape on long strip that is up past his other properties. The request is to cut off six acres in the front of it and leave the back half adjacent.

P & Z Director Victoria explained that the variance they are requesting is from the Fremont County Subdivision regulations appendix one section B number 10, which the standard that states where possible the depth of the lot should not be greater than twice the width. Lot number one is as proposed 10.05 acres lot, lot number two is six acres. Both lots are in the agricultural rural zone district. The applicant has attempted a reconfiguration once, it doesn't meet the width standard currently, so this reconfiguration doesn't really make anything worse. However, due to the regulations Mr. Victoria recommends denial or reconfiguration. When this was presented to the planning commission, they believed it was acceptable to grant this variance. Mr. Victoria recommended that if they were to approve this variance that a contingency be, any red lines on the plat are finished prior to recording.

Commissioner Grantham moved to approve of the lot line adjustment 24-003 Bartelmay requesting a lot line adjustment for 1919 Arnold Drive, Cotopaxi, CO with the contingency of the red lines on the plat to be finished before the recording. 7. Approval of contract with Advanced Professional Services for Fremont County building security

Administrator Carochi said that on July 10th Advanced Professional Security Services was selected from three vendors to provide building security coverage for the County Administration Building, the Garden Park Building, and Department of Human Services. This award was in response to the Fremont County bid that was posted on the Fremont County bid portal on May 13th, 2024. The county was very impressed with the depth and clarity of their proposal and their teams' qualifications and experience in private security. The company also has relief staff that can step in when another employee calls in sick or goes on vacation allowing the county to have security 24/7.

Commissioner Grantham moved to approve the contract with Advanced Professional Services for our Fremont County buildings security. Commissioner Bell seconded the motion. Mr. Gates handed out some flyers to the commissioners that advertise the event they are applying for the Special Event Liquor permit. Mr. Gates explained that it is a two-day event, and they are requesting to sell beer on both evenings. One being at the chuck wagon dinner which will the from 4:00pm until 9:00pm on Friday August 9th. The other is the banquet on Saturday night from 4:00pm until 10:00pm on August 10th. A lady from the VFW, that is the bartender, will be serving the fermented malt beverages.

Commissioner McFall asked what the money is being raised for.

Mr. Gates said the money goes to the mission of the Colorado for Responsible Wildlife Advancement, the mission is to support to enhance, promote, and defend the North American model of wildlife conservation and responsible wildlife management.

BOCC Clerk Sammy Ryan gave the staff report stating the 45day requirement was met, all necessary paperwork was submitted, the map was adequate allowing the Sheriff to recommend approval. Public Health also recommended approval after seeing the Event Coordinator Application. The clerk's office recommends approval.

Commissioner Bell moved to approve the issuance of a malt, vinous, and spiritous and fermented malt beverage special events permit for the Colorado Trapper Predators Hunters for an event at Pathfinder Park and Event enter in Florence on August 9th from 4:00pm to 9:00pm and August 10th from 4:00pm to 10:00pm in 2024.
