4. TUP 24-007 950 Junktion

The owner/applicant is requesting a Temporary Use Permit to allow a vintage / flea market for four consecutive weekends starting September 14th and ending October 6th. The event will be conducted on private property owned by the applicant Daniel Vinton. Mr. Vinton is expecting 15 venders and two food trucks each weekend. And is estimating a maximum of 43 attendees, at one time. Location and/or street address of the event will be 43880 West U.S. Highway 50, Cañon City, CO. 81212.

Applicant: Tracy Vinton

Mrs. Vinton and her husband Dan own the property, the request is for the next four weekend to have at most 15 vendors, two food trucks, no alcohol. This event will not be ticketed. The concept would be close to an upscale antique flea market. They have completed the traffic analysis and appeared CDOT by putting asphalt at the entrance of the property.

Planning and Zoning Director Victoria said this request is called TUP 24-7. The request is for September 14th to October 6th, the event will include four consecutive weekends of flea markets, 15 vendors, two food trucks, and around 43 attendees at one time. The applicant suggested one chemical toilet as well as an ADA accessible one, bottled water be provided, and a hand washing station. The Fremont County Sheriff's and Colorado State Patrol have been notified with no complaints or comments. Department of Public Health requests if any food vendors are licensed outside of Fremont County that they submit a vendor packet with a current license to the health department. Fremont County zoning resolution staff recommends approval of the Temporary Use Permit application.

Commissioner Grantham moved to approve TUP 24-007 950 Junktion the vintage flea market for the four consecutive weekends from September 14th to October 6th located at 43990 West US HWY 50 in Canon City, CO 81212, including the contingency for the approval of the chemical toilets and the approval of the waiver for the surety bond.
