There was no New Business to discuss.

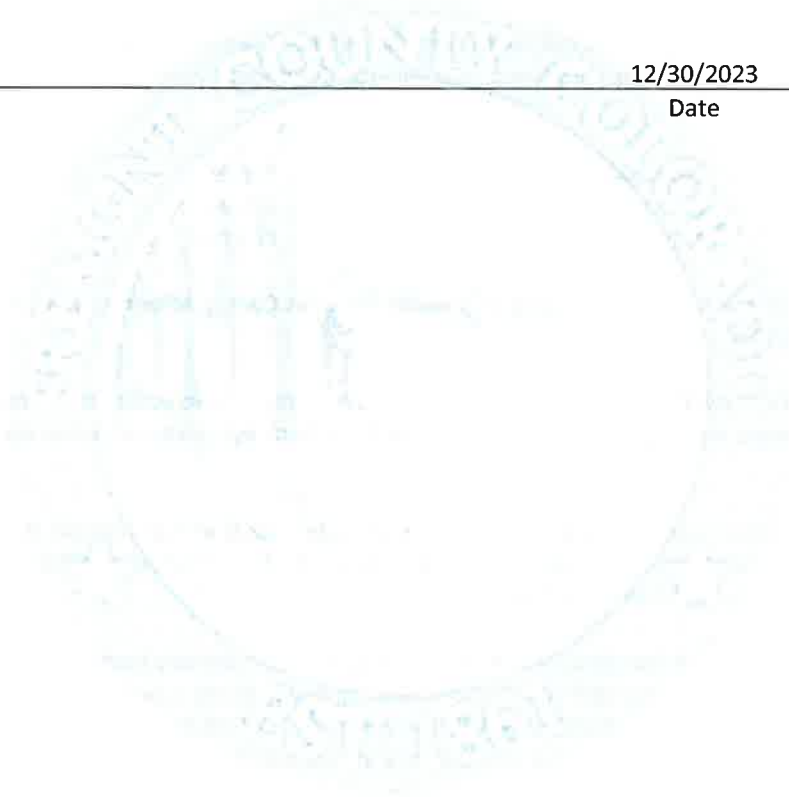


