OLD BUSINESS:



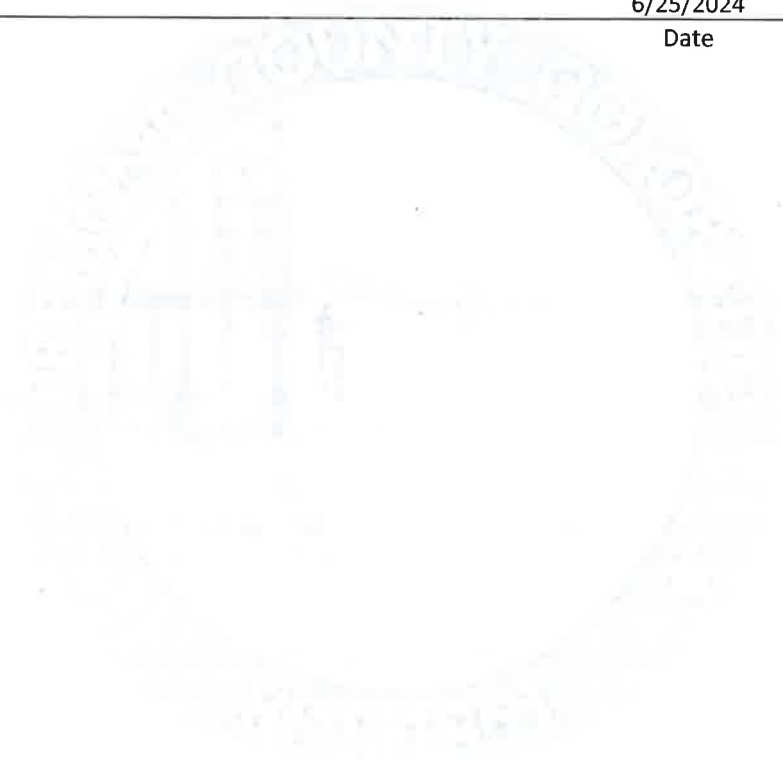
