The Fremont County Board of Human Services (BOHS) met in Regular Session Tuesday, June 30, 2020, in Conference Room LL3 at the Fremont County Administration Building, 615 Macon, Cañon City, Colorado. Chairman Payne called the meeting to order at 2:06 p.m. Those present included:

Also present: Brenda Jackson, Fremont County Attorney, Sunny Bryant, Fremont County Manager, and Stacie Kwitek-Russell, Director, Department of Human Services (DHS).

<u>MINUTES:</u> Board Member Bell moved, duly seconded by Board Member McFall, to accept the minutes of the May 26, 2020 meeting with no additions or deletions. Upon vote: Board Member Payne, aye; Board Member McFall, aye, Board Member Bell, aye. The motion carried.

AGENDA: There were no additions or revisions requested for the agenda. Board Member Bell moved, duly seconded by Board Member McFall, to approve the June 30, 2020 meeting agenda. Upon vote: Board Member McFall, aye; Board Member Bell, aye; Board Member Payne, aye. The motion carried.

FINANCIAL/CASELOAD REPORT: Stacie Kwitek-Russell explained the current allocation reports, stating that HCPF Admin would be covered by County Admin funds during close-out. Following review and discussion of the financial and caseload reports, Board Member McFall moved, duly seconded by Board Member Bell to accept the May financial and caseload reports. Upon vote: Board Member McFall, aye; Board Member Bell, aye; Board Member Payne, aye. The motion carried.

<u>DIRECTOR'S REPORT:</u> Stacie Kwitek-Russell provided the Board with a written report discussing current activity within the Department with an addendum to the written report reflecting the 20-21 SFY allocation figures and an update on current and upcoming expenditures. She also presented a re-opening plan for the building with the following questions: When transporting clients are masks required or encouraged, the answer was required. Do we have to take names down of everyone who enters the building, the answer was no. Can we post entry only for those with business in the building, no loitering, the answer was yes. Can cubicle walls serve the same purpose as plexi-glass, is there still a limit of no more than ten in a room or is it six foot distancing or is it 50% capacity, she was advised to ask the Public Health Director for clarification on those questions.

Stacie Kwitek-Russell then provided an update on the most current program area changes. The Single Entry Point program transition is going smoothly. Child Care (CCCAP) will continue to pay for additional absences and parent fees through August, and the federal waiver for SNAP has ended meaning there are no additional dollars issued, no waived interviews, and no extended redeterminations. There is an anticipated surge in eligibility and she requested receiving some of the CARES Act dollars for overtime. She said caseloads will increase with new requirements, and we don't have available space to hire additional workers.

Stacie Kwitek-Russell stated that she was just notified that the shelter has been utilized for high risk homeless individuals.

She then informed those present that she has been working with the County IT Department to have a technician housed at DHS. A list of daily supports that can be provided has been developed.

After a full discussion, Board Member Bell moved, duly seconded by Board Member McFall, to accept the monthly report. Upon vote: Board Member McFall, aye; Board Member Bell, aye; Board Member Payne, aye. The motion carried.

OLD BUSINESS:

There was no Old Business to discuss.

NEW BUSINESS:

Stacie Kwitek-Russell requested that the lease to Loaves and Fishes be extended for 30 days through July 31st for sheltering purposes. After discussion, Board Member McFall moved, duly seconded by Board Member Bell to approve the extension of the lease agreement with Loaves and Fishes. Upon vote: Board Member McFall, aye; Board Member Bell, aye; Board Member Payne, aye. The motion carried.

With there being no other business to discuss, the meeting adjourned at 2:30 p.m.

- Since the last BOHS meeting, our building has reopened. We intentionally did not do
 any publicity around the change, to allow for a soft reopening. News has quickly
 traveled, however and our lobby is busier with each passing day. We have implemented
 extensive precautionary measures to ensure safe practices to prevent the spread of
 COVID-19
- Our COVID I/Q Shelter continues to house two high risk individuals. There have three other people referred who ultimately chose not to utilize the service.
- Our '20-'21 Core Plan is in the final stages of preparation.
- I completed my annual team meetings this week. I enjoyed 1-2 hours with each team discussing what has gone well for them since our last meeting, what challenges have they faced, what cost control measures could they help us implement and what did they specifically need from management to more effectively do their job? I always learn a great deal and we now have an extensive list of issues to review and address. We also learned what changes we've implemented that are proving effective and beneficial.
- We have begun our budget preparations. We now have our preliminary allocations for TANF \$1,718,414 (\$65,601) and CCCAP \$993,709 (\$107,603).
- We are experiencing significant turnover right now, with varying reasons for departure.
 We are currently seeking to hire 3 technicians in eligibility, four caseworkers and two case aides in Child Welfare.
- The Colorado Child Care Assistance Program has changed the rules temporarily starting August 1st, that qualified parents will have a parental fee of 7%; we have been waiving this fee for qualified parents for a few months now. Also, the paid absences through the program will return to 5, per CDHS rather than the 31 we were allowing since the waiver was approved at the onset of the COVID crisis.
- CDHS has requested a waiver to allow for maximum SNAP benefits to qualified households for the month of August; they are awaiting a federal decision.
- We are holding our quarterly Professional Development Day on July 29th and the building will be closed. We are excited that our new phone system will be installed that day as well.
- We are undergoing an audit with CBI for our civil background checks. We will notify you
 of the results.

Extension of Term of Group Rental Agreement

WHEREAS the parties hereto previously entered into a Group Rental Agreement (the "Agreement") on May 1, 2020 (the "Effective Date") regarding premises consisting of a camper located at 241 Justice Center Road and 3 rooms at the New Creations Inn transitional housing site located at 2990 East Main Street, Cañon City, Colorado 81212, (collectively the Premises); and

WHEREAS the County has given notice that it desires to extend the Rental Period as provided in Paragraph 2 of the *Agreement*;

NOW THEREFORE, it is agreed as follows:

1. Extension of Rental Period. The rental period is hereby extended for a fourth additional monthly period until August 31, 2020. Such period may be further extended as provided in paragraph 2 of the *Agreement*.

All remaining provisions of the Agreement shall remain in full force and effect.
