MINUTES: Board Member Bell moved, duly seconded by Board Member Payne, to accept the minutes of the October 27, 2020 meeting with no additions or deletions. Upon vote: Board Member Payne, aye; Board Member Bell, aye. The motion carried.

AGENDA: There were no requested changes for the November 24, 2020 meeting agenda. Board Member Payne moved, duly seconded by Board Member Bell to accept the agenda. Upon vote: Board Member Payne, aye; Board Member Bell, aye. The motion carried.

FINANCIAL/CASELOAD REPORT: Stacie Kwitek-Russell noted that Child Care issuance had an increase and that one additional child care center closed temporarily due to COVID. She also said eligibility caseload numbers are staying steady, but the workload has increased due to cases being recertified that had previously been under a waiver. Following review and discussion of the financial and caseload reports, Board Member Bell moved, duly seconded by Board Member Payne to accept the October financial and caseload reports. **DIRECTOR'S REPORT:** Stacie Kwitek-Russell provided the Board with a written report on current activity within the Department which included COVID response efforts, the final financial information for the SEP closeout, safety and security within the building, recruitment and retention, and program updates.

After a full discussion, Board Member Bell moved, duly seconded by Board Member Payne, to accept the monthly report. Upon vote: Board Member Payne, aye; Board Member Bell, aye. The motion carried.

#### **OLD BUSINESS:**

Stacie Kwitek-Russell shared that the decision had been made to not have any team Christmas gatherings. The early building closure is still approved, and Sunny Bryant explained all employees will have two extra floating holiday hours to use for the time that the building is closed.

### **NEW BUSINESS:**

Director Kwitek-Russell provided a full update on COVID management. She said the Department has moved to having many staff work from home. There have been technology problems and some employees have come back to work in the office. She requested approval to be open by appointment only. Debbie Bell asked if people are productive at home, and Stacie said yes for the majority but it's being monitored. She also added that an app has been ordered that will use office extensions on employees' personal cell phones and the State has set up VPNs, which has been helpful.

Debbie Bell gave an update from a CCI call where she learned the State is looking at giving 3,500 to 35,000 for child care centers. Stacie said the feedback she is getting from centers is that it is costly to get the centers running, and that maybe these funds can be used for that.

Stacie Kwitek-Russell finished the discussion saying she appreciates the support for Built For Zero (BFZ), and a request has been made to the City and she's waiting to hear back.

With there being no other business to discuss, the meeting adjourned at 2:34 p.m.
