Since my last report, the following are many of my activities:

- I attended the Winter CCI Conference, where we had several sessions regarding Family First Prevention and Services Act. We also had an informative session from Health Care Policy and Financing and a particularly poignant session regarding Teen Suicide.
- The Built For Zero team held our VI-SPDAT training in which we had an incredible turnout. That same day we held our Case Conferencing Planning meeting. The first case conferencing was held two weeks later. Carrie Porter and Rochelle Reiter will be the primary representatives for DHS. We have already found huge benefits to case conferencing. Other good news on the BFZ front is that UAACOG did receive confirmation that they were approved for the grant request submitted to the RAE for reinvestment funds for a Housing Navigator. This will be extremely helpful.
- I participated in most of my monthly meetings with community partners.
- From December 10<sup>th</sup> through December 18<sup>th</sup>, I met with each team to discuss what has gone well for their team during the past year, what challenges they faced, and what the management team could do to assist them to do their jobs more effectively and/or efficiently. One issue arose that required consultation with the County Attorney and County Human Resources Manager.
- I was thrilled to attend the Fremont County Employee of the Year Nominee recognition and announcement of the selected employee. We had an agency celebration that afternoon with cake for all of the nominees.
- December has been filled with Christmas parties and planning for the children in Child Welfare. We have a very generous community that showers our Child Welfare children with gifts and food to make this a special time of year for them, to ease the pain of their situation.
