The Fremont County Board of Human Services (BOHS) met in Regular Session Tuesday, October 26, 2021 in Conference Room 207 at the Fremont County Administration Building, 615 Macon, Cañon City, Colorado. Chairman Grantham called the meeting to order at 2:15 p.m. Those present included:

He also discussed the Fremont Interagency Oversight Group (FIOG) being moved into a large county category based on the number of youth and children served during the last year, which means the incentive dollars the group received significantly increased. Commissioner Bell asked about an update for the Homeless Coalition, and he provided a review of the last meeting he attended. After a full discussion, Board Member Bell moved, duly seconded by Board Member McFall, to accept the monthly report. Upon vote: Board Member McFall, aye; Board Member Bell, aye; Board Member Grantham, aye. The motion carried.
