The existing use of the property is zipline obstacle course. With the intended use of the property remaining unchanged, with unmanned cell tower located on the property. Vehicular access should remain the same after construction (2 private vehicles with daily use).

After construction the proposed traffic for the cell tower would be one vehicle 4-6 times a year for maintenance or in some circumstances additional trips if there is a problem. No fleet vehicles and fleet equipment are present full time on site. Increased traffic during construction only. It is unmanned so No employees will be stationed at the cell site. The cell tower itself will operate 24/7 independent of personnel. The width of and location of access is outlined in the construction drawings and survey attached. The proposed tower is 49' and will be capable of colocation.
