## Please read the entire application form prior to completion of this application

**Description:** An Extended Plant Count Permit is to allow those who have a need and desire to grow more than the allowed twenty four plants through County Ordinances. In addition it allows the County to address associated issues with larger private grows. The approval of this permit allows for a maximum of ninety-nine (99) plants to be located on the approved property.

**Definition:** An Extended Plant Count Permit is a specifically designed permit to address personal cultivation of marijuana for individuals who wish to grow in a co-op type setting, have medical needs that require an extensive plant count, and for caregivers whose patients require additional plants.

## Please provide the following:

- 1.) A copy of the deed showing ownership and/or copy of lease agreement.
- 2.) Written proof of water and septic availability, or proof of existing systems and usability for the purpose proposed.
- 3.) A plot plan showing all structures and growing location on the property. Label all access points and security measures to be installed.
- 4.) A vicinity map showing the locations of adjoining lots and buildings. No extended plant grow will be permitted within 1000 feet of an adjacent residence.
- 5.) Provide a brief summary of odor and light mitigation. Per ordinance, only a ratio of 7:1 odor ratio will be permitted at the property boundary. Non-directional light will be permitted. Shades will be required to reduce glare and directional light.
- 6.) A list of all card numbers and plant counts associated with each card for the grow.
- 7.) An administrative fee of \$200 to Fremont County.

After a complete application has been received, the application will be reviewed by department staff and forwarded to the Board of County Commissioners.

This permit and the rules, laws and ordinances it represents shall be enforced by the Fremont County Sheriff and Fremont County Code Enforcement. The applicant signing this application is consenting to the review by Fremont County and periodic reviews of the site for compliance to this permit.

By signing this Application, the Applicant, hereby certifies that all information contained in the application and any attachments to the Application, is true and correct to the best of Applicant's knowledge and belief.

Fremont County hereby advises Applicant that if any material information contained herein is determined to be misleading, inaccurate or false, the Board of Commissioners may take any and all reasonable and appropriate steps to declare actions of the Board regarding the Application to be null and void.
